#### **RESOLUTION NO. 215**

A RESOLUTION APPROVING THE AMENDMENT ON THE SHARING OF THE PHILIPPINE HEALTH INSURANCE CORPORATION MATERNITY CARE, ANTENATAL CARE, NEWBORN CARE, INTRAUTERINE DEVICE (IUD) INSERTION AND ANIMAL BITE TREATMENT PACKAGES OF FINANCIAL BENEFITS FOR MAASIN CITY HEALTH PERSONNEL.

WHEREAS, the Philippine Constitution mandates the state to adopt an integrated and comprehensive approach to health development;

WHEREAS, in developing the different packages of health services, the Philippine Health Insurance Corporation (PhilHealth) through PhilHealth Circular No. -15 S.2012 and PhilHealth Circular No. 022-2014, recognizes the health human resource as priceless assets of our country, by providing them financial benefits from these packages;

WHEREAS, for the PhP 8,000.00 received by the Local Government Unit (LGU) from PhilHealth under Maternal Care Package Program, shall be applied as follows: 60% as facility fee and 40% as professional fee. The PhP 1,500.00 for the Antenatal Care Component: 60% as facility fee while 40% as professional fee;

WHEREAS, for the Newborn Care Package of Php 1,750.00 to the health facility, PhP 500.00 of which is paid to the health personnel as professional fee;

WHEREAS, for IUD insertion benefits, PhilHealth pays PhP 2,000.00 of which, Php 800.00 is paid to the health personnel as professional fee, and PhP 1,200.00 to the facility;

WHEREAS, for Animal Bite Treatment Package, PhilHealth pays PhP 3,000.00 to the health facility of which PhP 300.00 is paid to the health personnel as professional fee;

WHEREAS, the benefits for health personnel from the Philippine Health Insurance Corporation package of services can somehow augment their income, entice them to remain in the country and in the government sector;

WHEREAS, a legal and concrete basis is necessary for the release and payment of the financial benefits to the health workers;

NOW WHEREFORE, on motion of Hon. Ricky L. Montalbo duly seconded by Hon. Romeo R. Geniston, BE IT. . .

RESOLVED, as it is hereby resolved, by the Sangguniang Panlungsod of the City of Maasin in session, to approve, as it is hereby approved, the amendment on the sharing of the Philippine Health Insurance Corporation Maternity Care, Antenatal Care, Newborn Care, Intrauterine Device (IUD) Insertion and Animal Bite Treatment Packages of Financial Benefits for Maasin City Health Personnel, with guidelines and sharing scheme pursuant to PhilHealth Circular No. 015 S.2012 and PhilHealth Circular No. 022-2014 be imposed as follows:

- I. Maternity Care Package (PhP 8,000.00)
  - A. The 40% (PhP 3,200.00)-Professional Fee shall be divided as follows:
    - a. 25% (PhP 800.00) for the City Health Officer
    - b. 30% (PhP 960.00) for the Delivery Room (DR) staff of which PhP 500.00 shall be given to the one directly handling the delivery and the remaining PhP 460.00 shall be divided by the assistants.
    - c. 12.5% (PhP 400.00) for the midwife doing the pre-natal check up and referral
    - d. 12.5% (PhP 400.00) shall be divided by the medtech, nurse and dentist
    - e. 20% (PhP 640.00) shall be divided by the clerk, utility, driver/s, guard, etc and the amount shall be based on the gravity and nature of work.
  - B. The 60% of the component shall be for the facility fee which shall be used for the following: medicines, laboratory supplies, improvement of the labor room, delivery room and others necessary for the delivery of efficient basic health services.
- II. For Antenatal Care Package Only. (In case when the pregnant woman receives prenatal care from another facility, the facility where the prenatal care is rendered may claim for Antenatal Care Package while the facility that will assist in normal delivery may claim for Normal Spontaneous Delivery (NSD Package).

A. The case rate is PhP 1,500.00 for which forty percent (60%) is for Facility Fee while B. The (40%) is for the Professional Fee which shall be divided as follows:

- PhP 90.00 (15%) for the physician
- Php 360.00 (60%) for the midwife
- Php 60.00 (10% shall be divided by the medtech
- Php 60.00 (10%) for the dentist
- Php30.00 (5%) for the Clerk
- III. Newborn Care Package (PhP 1,750.00). Php 500.00 as Professional Fee shall be divided as follows:
  - PhP 200.00 (40%) for the attending physician;
  - PhP 250.00 (50%) for the midwife/staff who performed the Newborn Screening(NBS) Test
  - PhP 50.00 (10%) for the referring midwife
- IV. IUD Insertion Benefits (PhP 2,000.00). Php 800,00 as Professional Fees shall be divided as follows:
  - PhP 200.00 (25%) for the attending physician
  - > PhP 360.00 (45%) for the staff who performed the IUD insertion
  - > PhP 80.00 (10%) for the assistant
  - > PhP 40.00 (5%) for the Clerk
  - PhP 120.00 (15%) for the referring midwife

# V. Animal Bites Treatment Center Package.

A. Professional Fee of Php 300.00 shall be divided as follows:

- 50% for the attending physician
- 30% for the CHU staff performing the vaccination
- 10% for the assistant who continue the vaccination and referring midwife
- 5% for the Clerk
- 5% for the referring health worker

The PhP 1,500.00 for the Antenatal Care Component: 60% as facility fee while 40% as professional fee;

WHEREAS, for the Newborn Care Package of Php 1,750.00 to the health facility, PhP 500.00 of which is paid to the health personnel as professional fee;

WHEREAS, for IUD insertion benefits, PhilHealth pays PhP 2,000.00 of which, Php 800.00 is paid to the health personnel as professional fee, and PhP 1,200.00 to the facility;

WHEREAS, for Animal Bite Treatment Package, PhilHealth pays PhP 3,000.00 to the health facility of which PhP 300.00 is paid to the health personnel as professional fee;

WHEREAS, the benefits for health personnel from the Philippine Health Insurance Corporation package of services can somehow augment their income, entice them to remain in the country and in the government sector;

WHEREAS, a legal and concrete basis is necessary for the release and payment of the financial benefits to the health workers;

- I. Maternity Care Package (PhP 8,000.00)
  - A. The 40% (PhP 3,200.00)-Professional Fee shall be divided as follows:
    - a. 25% (PhP 800.00) for the City Health Officer
    - b. 30% (PhP 960.00) for the Delivery Room (DR) staff of which PhP 500.00 shall be given to the one directly handling the delivery and the remaining PhP 460.00 shall be divided by the assistants.
    - c. 12.5% (PhP 400.00) for the midwife doing the pre-natal check up and referral
    - d. 12.5% (PhP 400.00) shall be divided by the medtech, nurse and dentist
    - e. 20% (PhP 640.00) shall be divided by the clerk, utility, driver/s, guard, etc and the amount shall be based on the gravity and nature of work.
  - B. The 60% of the component shall be for the facility fee which shall be used for the following: medicines, laboratory supplies, improvement of the labor room, delivery room and others necessary for the delivery of efficient basic health services.
- II. For Antenatal Care Package Only. (In case when the pregnant woman receives prenatal care from another facility, the facility where the prenatal care is rendered may claim for Antenatal Care Package while the facility that will assist in normal delivery may claim for Normal Spontaneous Delivery (NSD Package).

A. The case rate is PhP 1,500.00 for which forty percent (60%) is for Facility Fee while B. The (40%) is for the Professional Fee which shall be divided as follows:

- PhP 90.00 (15%) for the physician
- Php 360.00 (60%) for the midwife
- Php 60.00 (10% shall be divided by the medtech
- Php 60.00 (10%) for the dentist
- Php30.00 (5%) for the Clerk
- III. Newborn Care Package (PhP 1,750.00). Php 500.00 as Professional Fee shall be divided as follows:
  - PhP 200.00 (40%) for the attending physician;
  - PhP 250.00 (50%) for the midwife/staff who performed the Newborn Screening(NBS) Test
  - PhP 50.00 (10%) for the referring midwife
- IV. IUD Insertion Benefits (PhP 2,000.00). Php 800.00 as Professional Fees shall be divided as follows:
  - PhP 200.00 (25%) for the attending physician
  - > PhP 360.00 (45%) for the staff who performed the IUD insertion
  - > PhP 80.00 (10%) for the assistant
  - > PhP 40.00 (5%) for the Clerk
  - > PhP 120.00 (15%) for the referring midwife

- 50% for the attending physician
- 30% for the CHU staff performing the vaccination

- 5% for the referring health worker

# AN ORDINANCE IMPLEMENTING THE MATERNAL CARE INCENTIVE PROGRAM (MCIP), PRESCRIBING THE IMPLEMENTING RULES AND REGULATIONS AND FOR OTHER PURPOSES.

Introduced by HON. MELVIN M. DUBLAN Chairman, SP Committee on Health

## **EXPLANATORY NOTE**

Improving the well-being of mothers, infants and children is an important public health goal of the state. Their well-being is fundamental to the health of the next generations and helps predict future public health challenges for families, communities and health care systems. It is imperative for the local government unit to respond to the needs of pregnant women in relation to pre-natal, delivery and post natal care by making these services available in accredited birthing facilities of its health units.

The City Government of Maasin partners with PhilHealth in the latter's programs that aim to motivate pregnant women to avail of the services of the former's birthing facilities. Such incentives program is channelled through the LGU in order to also maximize the services of local health workers in promoting for the safety of women during pregnancy, delivery and post-natal periods. It is to this effect that this Ordinance is enacted.

# CITY ORDINANCE NO. 2018-114

# AN ORDINANCE IMPLEMENTING THE MATERNAL CARE INCENTIVE PROGRAM (MCIP), PRESCRIBING THE IMPLEMENTING RULES AND REGULATIONS AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Maasin in session assembled, that,

**SECTION 1. TITLE**. This Ordinance shall be entitled "AN ORDINANCE IMPLEMENTING THE MATERNAL CARE INCENTIVE PROGRAM (MCIP) AND PRESCRIBING THE IMPLEMENTING RULES AND REGULATIONS AND FOR OTHER PURPOSES". For brevity, the shall be called "The Maternal Care Incentive Ordinance"

SECTION 2. AUTHORITY AND PURPOSE. As provided for in Article II, Section 15 of the Philippine Constitution, the "State shall protect and promote the right to Health of the people and to instil health consciousness among them," and Article XIII, Section II further states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavour to make essential goods, health, and other social services available to all people at affordable cost. There shall be priority for the needs of the underprivileged, sick, disabled woman and children. Further to carry out the objectives of RA 9710 otherwise known as the "Magna Carta of Women" and to fully support the Millennium Development Goals (MDGs).

SECTION 3. SCOPE AND APPLICATION. This Ordinance shall be adopted by the City in the implementation of the Maternal Care Incentive Program (MCIP).

# SECTION 4. UNDERTAKINGS OF THE CITY GOVERNMENT OF MAASIN

4.1 The City Government shall ensure the prioritization and enrolment of all pregnant mothers to PhilHealth;

4.2 The City Government shall undertake to pay the amount of P1,500.00 by way of incentive to pregnant mothers who availed the services of the accredited City Health Unit birthing facilities which amount shall be taken from Maternity Care Package (MCP) reimbursement;

4.3 Upon issuance of certification by the City Health Officer concerned certifying that the pregnant woman availed the services of the birthing facility, the City Health Officer shall release the incentive to the former in the aforementioned amount:

4.4 The amount of P1, 500.00 shall be released to the recipient in full only after the following conditions are met as certified by the City Health Officer concerned:

a. Four (4) prenatal visits to the health center,

b. Delivery at the accredited birthing facility; and,

c. Two (2) post partum care visits at the accredited birthing facility.

4.5 A Health Worker Volunteer (HWV) shall be entitled to cash incentive in the amount of P525.00 for each pregnant woman referred by him/her to the accredited birthing facility provided the former assisted the latter in complying the conditions set forth in Section 4.4;

4.6 The amount of P525.00 shall only be paid to the Health Worker Volunteer (HWV) upon issuance by the City Health Officer of the certification referred to in Section 4.3;

4.7 That pregnant mother shall be a PhilHealth member or dependent;

4.8 That payment shall be made only to both the Patlent and Health Worker Volunteer (HWV after the birthing facility receives the claims from PhilHealth;

SECTION 5. CITY HEALTH OFFICE TRUST FUND. A Trust Fund is hereby created and established for any funds acquing to the City from PhilHealth Benefit Payment for the Health related services rendered by the City Birthing Facilities.

SECTION 6. ENFORCEMENT AGENCY. The City Health Office shall be the lead agency in the enforcement of the Ordinance and the Maternal Care Incentives Program. The Office of the City Treasurer shall provide its services in the disbursement of funds due to the respective beneficiaries.

Section 7, REPEALING CLAUSE. Any Ordinance found inconsistent with this Ordinance is hereby modified or repealed.

Section 8. SEPARABILITY CLAUSE. Any part of this Ordinance that is declared null and void shall not have any effect on the entirely of the Ordinance.

Section 9. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval and after furnishing a copy of the same to the PhilHealth Regional Office 8 and others concerned.

# CITY ORDINANCE NO. 2019-125

AN ORDINANCE PROMOTING A DRUG-FREE WORKPLACE IN THE CITY OF MAASIN AND PROVIDING SANCTIONS THEREROF AND FOR OTHER PURPOSES.

#### Introduced by HON. PEPITO G. GENERAN Chairman, SP Committee on Peace and Order

HON. GERONIMO O. MERCADO SP Representative to the City's Personnel Selection Board

### EXPLANATORY NOTE

WHEREAS, the Civil Service Commission (CSC) issued Resolution No. 101359 which prescribes the conduct of mandatory drug test as a requirement for pre-employment to ensure that only those qualified shall be screened and recruited in the government service;

WHEREAS, the same resolution mandates the heads of agencies to ensure that the drug-free workplace program on the prevention and control of dangerous drugs, including drug-testing shall be disseminated to all officials and employees:

WHEREAS, Section 36 (d) of RA 9165 otherwise known as the Comprehensive Dangerous Drugs Act of 2002 provides that officers and employees of public and private offices, whether domestic or overseas, shall be subjected to undergo a random drug test as contained in the company's work rules and regulations, which shall be borne by the employer, for the purpose of reducing the risk in the workplace;

WHEREAS, public office is a public trust, thus, public officers must at all times be accountable to the people, serve them with utmost degree of responsibility, integrity, loyalty and efficiency:

WHEREAS, it is in the best interest of the government to create a drug-free workplace since drug abuse problem, if there is any, can have adverse and far reaching effects on the government, like reduced productivity, poor decision making, client relationship mishap and physically dangerous situations;

WHEREAS, under Sec.458, per (a), (1) and (V) of RA 7160, the Sanggunlan shall appropriate penalties on drug addiction, maintenance of drug dens, drug pushing and such other activities inimical to the welfare and moral of the inhabitants of the city.

# CITY ORDINANCE NO. 2019-125

# AN ORDINANCE PROMOTING A DRUG-FREE WORKPLACE IN THE CITY OF MAASIN AND PROVIDING SANCTIONS THEREROF AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Maasin, in Regular Session assembled, that:

SECTION 1. SHORT TITLE- This ordinance shall be known as "A DRUG-FREE WORKPLACE ORDINANCE IN THE CITY OF MAASIN".

SECTION 2. GENERAL GUIDELINES IN THE CONDUCT OF RANDOM DRUG TESTING AS GOVERNMENT POLICY AND AS PART OF EMPLOYEES RULES AND REGULATIONS- This ordinance shall be applicable to the random drug testing of all elected officials, appointed heads of offices and rank and file employees of all appointment statuses of the City Government of Maasin. The following guidelines outline the purposes of the random drug testing program:

a. The random drug testing shall be implemented as a collaborative undertaking of the government, its officials and employees, local and national.

b. Random drug testing shall be implemented primarily for a drug-free workplace.

c. The drug testing program shall guarantee and respect the personal privacy and dignity of the officials and employees.

d. The random drug testing may be set as a condition for the continuous financial assistance of the city government to national government agencies, same condition may be set for the approval of business permit/franchise to local merchants/pedicabs/motorcab operators.

SECTION 3. DEFINITION OF TERMS. For the purpose of this ordinance, the following terms are defined:

- 1. Employees- shall include all local and national officials and regular, casual, job order personnel, contractual and temporary employees in the City Government of Maasin.
- 2. Random Drug Test- subjection of personnel for drug testing as selected following no specific pattern and without prior notice/information:
- 3. "For Cause" or Probable Cause" Drug Test- Drug testing required when there is "probable cause" or "reasonable ground" to believe that a person is using or is under the influence of dangerous drugs.
- 4. Screening Test- shall mean a rapid test performed to established potential/presumptive positive result; it refers to the immunoassay test to eliminate a negative specimen i.e. one without the presence of dangerous drugs, from further consideration and to identify the presumptively positive specimen that regulies confirmatory test.
- 5. Confirmatory Test- shall mean an analytical test using a device, tool or equipment with a different chemical or physical principle that is more specific which will validate and confirm the the result of the screening test; it refers to the second or further analytical procedure to more accurately determine the presence of dangerous drugs in a specimen.

# SECTION 4. CREATION OF A DRUG-FREE WORKPLACE COMMITTEE.

a. A Drug-Free Workplace Committee shall be created by the City Mayor composed of himself as chairperson and representatives from the City Health Office, Office of the Human Resource Management, City Legal Office, Office of the City Administrator and the City of Maasin Anti Drug Abuse Council (SCCADAC).

b. The Drug-free Workplace Committee shall formulate the implementing rules and regulations for the implementation of this ordinance.

SECTION 5. PROCEDURES IN THE CONDUCT OF RANDOM DRUG TESTING – the procedures in the conduct of the random drug testing are as follows:

1. Drug testing shall be done by any government forensic laboratory or any of the local drug testing laboratories accredited and monitored by the DOH to safeguard the quality test results.

2. The drug testing shall employ, among others, two (2) testing methods:

a. the screening test which will determine the positive result as well as the type of drug used; and b. the confirmatory test which will confirm a positive screening test.

3. Random testing shall include, either all or a certain number of employees; the means of selection shall remain confidential.

4. All information related to drug testing or the identification of persons as users of drugs shall be treated by the City as confidential unless otherwise required by law, overriding public health and safety concerns, or authorized in writing by the person in question.

SECTION 6. TESTING FOR "PROBABLE CAUSE" OR "REASONABLE GROUND"- Random Drug test shall be conducted when certain employee/s displays misconduct, e.g.:

a. Attendance- frequent unauthorized absences, repeated tardiness, truancy from the job.

b. Personal Appearance - slurred speech, bloodshot eyes, drastic change in appearance, etc.

c. Mental Factor - hot-headedness, irritability, increased difficulty in handling assignments, etc.

d. General Performance – missed deadlines, low productivity, increased wastage, public complaints, frequent accidents, carelessness, etc.

e. Peer Relation – isolation, frequent quarrels with officemates, heavy borrowing, frequent mood swings, etc.

#### SECTION 7. FUNDING

Funding for the random during drug testing shall be taken from the Maasin City Peace and Order Funds.

#### SECTION 8. SANCTION

1. Any official or permanent or regular employee found positive of dangerous drugs shall be subjected to disciplinary/administrative and criminal proceeding, and immediate dismissal after release of confirmatory result for the job order personnel, contractual and temporary employee.

2. The refusal to undergo drug testing shall be ground for disciplinary and administrative sanction.

SECTION 9. SEPARABILITY CLAUSE. If any part of this Ordinance is declared not valid unconstitutional or unlawful, such declaration shall not effect or Impair the remaining provisions, section or parts thereof, which shall remain or continue to be full force and effect.

SECTION 10. REPEALING CLAUSE. All previous ordinances and provisions inconsistent with this Ordinance shall be deemed repealed or modified accordingly.

SECTION 11. EFFECTIVITY. This Ordinance shall take effect, after its publication in a newspaper of general circulation and after copies of this Ordinance shall have been posted for ten (10) days in the builtetin board, at

# EXPLANATORY NOTE

President Rodrigo Roa Duterte himself ordered the banning of the use of vaporizers or vapes because of their harmful effects to their users similar to smoking cigarettes and other tobacco products.

The public has to be warned that vaping is also strictly prohibited in the same places where smoking is banned in the City of Maasin.

The increasing number of lung illness and death due to the use of vapes prompted the amendment of the ordinance as additional warning.

Additional penalties such as imprisonment and amendment of fines imposed on persons and owners of business establishments are also included in the amendments to the Ordinance.

BE IT ENACTED by the Sangguniang Panlungsod of the City of Maasin duly assembled in session, that:

**SECTION 1.** Section 3 Definition of Terms of City Ordinance No. 2017-085 is hereby amended to include the following:

SECTION 3. DEFINITION OF TERMS. As used in this ordinance, the following terms shall have the meanings ascribed to them in this Section, unless the context of their usage indicates another meaning:

<u>h.) VAPING – having In one's possession or control of an emission</u> producing electronic cigarette or battery powered vaporizer that simulates smoking and provides some behavioral aspects of smoking, including the hand-to-mouth action of smoking, but without burning tobacco.

i.) <u>Illegally-sold tobacco or tobacco products shall mean more than one (1)</u> ream or more than ten (10) packs of cigarettes, or more than three (3) pieces of vaporizers/vapes or electronic/e-cigarettes and their accessories in possession of the person or establishment even if not in the act of selling; or any quantity of tobacco, tobacco products, vaporizers/vapes or electronic/e-cigarettes and their accessories used in the act of selling.

SECTION 2. Section 5 (a) of City Ordinance No. 2017-085 is hereby amended to read as follows:

SECTION 5. Duties and Obligations of Persons In-charge. Persons incharge shall:

a. Post and display prominently NO SMOKING <u>AND NO VAPING</u> signages in the most visible locations in the area where smoking is prohibited, including public utility vehicles, in order to ensure that the public can easily view and be notified. At the very least, a NO SMOKING <u>AND NO</u> <u>VAPING</u> sign must be posted at the entrance of the prohibited area. The NO SMOKING <u>AND NO VAPING</u> signages shall be at least 8x16 inches in size and the International no smoking symbol (consisting of a pictorial representation of a burning cigarette enclosed in a red circle with a red bar across it ) shall occupy no less than 70% of said signage. The remaining lower 30% of the signage shall show the following warning prominently:

> "STRICTLY NO SMOKING <u>AND NO VAPING</u> AS PER CITY ORDINANCE NO. 2020-135"

- b. Remove all ashtrays or any receptacles for dispensing cigarette refuse from prohibited areas for smoking enclosed public places and workplaces, and other public outdoor spaces.
- c. Ensure that all the employees in the establishments are aware of the Ordinance and to provide a procedure for them to warn violators.
- d. Undertake all reasonable steps to ensure strict implementation of this Ordinance and to stop people from smoking such as but not limited to warning the violators and requesting them to leave the premises. If the violator fails to stop smoking or leave the establishment, the person in charge or his agent shall immediately report the violator to the Task Force Tobacco- Free City Enforcers or the nearest peace officer.

SECTION 3. Section 7 of City Ordinance No. 2017-085 is hereby amended to read as follows:

SECTION 7. PENALTIES. The following penalties shall be imposed on violations of this ordinance:

- a. First Offense:
  - <u>1. Fine of P300.00 for every person violating Section 4a, of this</u> <u>ordinance;</u>
  - 2. <u>Fine of P1,000.00 for every person or establishment violating</u> <u>Section 4b, 4c, 4d, 4e and 5 of this ordinance;</u>
  - <u>3. Confiscation of illegally sold tobacco and/or tobacco products,</u> <u>vaporizers/vapes and electronic/e-cigarettes and their</u> <u>accessories.</u>
- b. Second Offense:
  - <u>1. Fine of P500.00 for every person violating Section 4a of this</u> <u>ordinance and imprisonment of one to four (1-4) days at the</u> <u>discretion of the court:</u>
  - 2. Fine of P2,000.00 for every person and establishment violating Section 4b, 4c, 4d, 4e and 5 of this ordinance and imprisonment of five to ten (5-10) days at the discretion of the court;
  - <u>3. Confiscation of illegally sold tobacco and/or tobacco products, vaporizers/vapes and electronic/e-clgarettes and their accessories.</u>
- c. Third and Succeeding Offenses:
  - <u>1. Fine of P1,000.00 for every person violating Section 4a of this</u> Ordinance and Imprisonment of five to ten (5-10) days at the discretion of the court;
  - 2. Fine of P3,000.00 for every person or establishment violating Section 4b, 4c, 4d, 4e and 5 of this ordinance and imprisonment of eleven to twenty (11-20) days at the discretion of the court;
  - 3. Confiscation of illegally sold tobacco and/or tobacco products, vaporizers/vapes and electronic/e-cigarettes and their accessories
- d. The license to operate of any private establishment covered by this ordinance will be suspended upon:

- failure of the establishment to pay the fine indicated in a Citation Ticket within five (5) regular business days of its issuance, regardless of whether or not the Citation Ticket was accepted;

The establishment may be immediately opened upon proof of compliance for closure, payment of fines, or upon reversal of the retaliatory adverse personnel action.

- e. The license to operate of any private establishment covered by this Ordinance will be revoked for
  - iv) failure of the establishment to comply with this Ordinance within ten (10) days of receiving a Citation Ticket;
  - v) failure of the establishment to pay the fine indicated in the Citation Ticket within fifteen (15) regular business days of its issuance, regardless of whether or not the Citation Ticket was accepted.
- f. The franchise of a public conveyance of motorcycle, motorcab and trisikad for hire shall be suspended for at least one (1) week but not more than one (1) month upon a third and subsequent offense transpiring therein; (OR if the violator is a person in charge of a public conveyance, the vehicle used shall be prohibited from plying the LGU'S roads and waterways and from using public loading facilities, whether for good or passengers, for at least one (1) week but not more than one (1) month.

A new license or franchise to operate may only be granted upon proof of compliance and payment of all fines.

Proof of compliance shall be by means of a re-inspection of premises by the Task Force Tobacco-Free City and the Healthy City Enforcers. Costs of the re-inspection shall be borne by the violator.

# <u>Violators of this Ordinance shall undergo smoking cessation seminar to</u> be conducted by the Healthy Cities Initiatives Office.

**SECTION 5. SEPARABILITY CLAUSE**. If for any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provision hereof, which are not affected, shall continue to be in full force and effect.

**SECTION 6. REPEALING CLAUSE.** All ordinances and administrative circulars and executive orders, or part/s thereof, which are found to be inconsistent with the provision of this Ordinance, are hereby repealed, or amended accordingly.

SECTION 7. EFFECTIVITY. This ordinance shall take effect upon approval and compliance with the publication and/or posting requirements prescribed under Republic Act No. 7160.

AN ORDINANCE PROVIDING FOR THE PREVENTION, MITIGATION, PREPAREDNESS FOR AND CONTAINMENT OF THE 2019 NOVEL CORONAVIRUS ACUTE RESPIRATORY DISEASE (COVID-19), IMPOSING SANCTIONS FOR VIOLATION THEREOF AND FOR OTHER PURPOSES

#### EXPLANATORY NOTE

Based on the report of the World Health Organization (WHO) as of 05 March 2020, the novel coronavirus disease (COVID-19) has affected 85 countries with 14,678 confirmed cases and 267 deaths. In response to the growing concern over the outbreak of, and the declaration of the World Health Organization (WHO) that, the 2019 Novel Coronavirus Disease (COVID 19), is now a Public Health Emergency of International Concern.

Concrete and proactive steps must be undertaken to prevent, contain and restrict the possibility of preading epidemic within the territorial jurisdiction of the City of Maasin, Province of Southern Leyte.

Pursuant to Article 2, Section 15, of the 1987 Philippine Constitution, and Section 16-17, the General Welfare Clause of the Local Government Code, local government units are charged with the promotion of health and safety within their jurisdictions, including the provision of services to control communicable diseases. As such, they must take the lead in the prevention and control of corona virus at the local level

#### CITY ORDINANCE NO. 2020-136

# AN ORDINANCE PROVIDING FOR THE PREVENTION, MITIGATION, PREPAREDNESS FOR AND CONTAINMENT OF THE 2019 NOVEL CORONAVIRUS ACUTE RESPIRATORY DISEASE (COVID-19), IMPOSING SANCTIONS FOR VIOLATION THEREOF AND FOR OTHER PURPOSES

BE IT ENACTED by the Sangguniang Panlungsod of the City of Maasin duly assembled in session, that:

#### SECTION 1. TITLE. This Ordinance shall be known as the Anti-COVID-19 Ordinance of 2020.

**SECTION 2. DECLARATION OF POLICY.** It is hereby the policy of the State to protect and promote the right to health of the people and instill health consciousness among them. The State recognizes epidemics and other public health emergencies as threats to public health and national security, which can undermine the social, economic and political functions of the State. It is an adopted policy that the City Government shall promote and ensure the protection of the health and safety of its residents from all forms of communicable and non-communicable diseases, especially those which have epidemic effects.

The Philippines is already one of several countries with confirmed COVID-19 cases. As of 14 March 2020, there are 111 confirmed cases in the Philippines. This raises the level of urgency and immediate actions to prevent the occurrence of a national epidemic.

**SECTION 3. DEFINITION OF TERMS.** For purposes of this Ordinance, unless the contrary is indicated, the following terms mean and shall be construed as follows:

- a. COVID-19. It is a highly infectious respiratory disease caused by the most recently discovered coronavirus. The signs and symptoms include fever >38 degrees celsius and/or cough and other respiratory symptoms.
- **b.** Persons under investigation (PUI). Persons with either travel history in the past 14 days to areas with issued travel restriction and/or history of exposure and showing at least two (2) signs and symptoms of the coronavirus. They are mandated to undergo hospital admission.
- c. Persons under monitoring (PUM). Persons who have travel history in the past 14 days to areas with issued travel restriction and/or history of exposure and not showing signs and symptoms of the coronavirus. They are mandated to undergo 14-day self-quarantine.
- d. Local transmission shall mean transmission in a local geographical setting.

f.

Community transmission shall mean widespread transmission beyond the defined geographical area

**History of exposure**: This includes a) contact with a confirmed or probable case of COVID-19 infection or b) worked in or attended a health care facility where patients with confirmed probable COVID-19 patients were being treated. A contact is a person involved in any of the following:

- i. Providing direct care for COVID-19 patients, working with health care workers infected with novel coronavirus, visiting patients or staying in the same close environment of a COVID-19 patient;
- ii. Working together in close proximity or sharing the same classroom environment with COVID-19 patient;
- iii. Traveling together with COVID-19 patient in any kind of conveyance;
- iv. Living in the same household as a COVID-19 patient within a 14-day period after the onset of symptoms in the case under consideration.
- g. Quarantine shall mean the limitation of movement by competent authority, of persons who have been exposed or are suspected to have been exposed to a person inflicted with a communicable disease. This includes voluntary home confinement which is the voluntary limitation of movement of a person within the confines of the person's residence, for a period not less than fourteen (14) days.

# SECTION 4. RULES AND PROCEDURES FOR QUARANTINE OF SUSPECTED OR CONFIRMED CORONA VIRUS VICTIM

Persons under investigation are directed for mandatory hospital admission. Persons under monitoring are directed to undergo self-quarantine for 14 days.

Persons that were confirmed to have COVID-19 shall undergo a mandatory quarantine, or other confinement identified by the DOH. In case of minors, the minors shall be subject to confinement with consent/approval of parents or legal guardians.

The roles and responsibilities of local officials and teams are as follows:

#### a. Local Health Office, in close coordination with the Regional DOH-

- Regularly check the condition of the PUMs over the course of the home quarantine period through the Barangay Health Emergency Response Teams (BHERT);
- Issue certificate of completion of 14-day quarantine and clearance, as the case may be.

#### b. Philippine National Police

Directed to effect the compulsory confinement of persons arriving from a country with a confirmed COVID-19 case, who refuse to undergo home confinement, or voluntary quarantine at the Barangay Isolation Unit (BIU), and ensure they are able to complete the 14-day quarantine period, in the unlikely event that the Punong Barangay and the BHERT fail to convince the subject person or persons to voluntarily undergo the 14-day quarantine

#### c. Barangay Health Emergency Response Teams

 If symptoms are observed, immediately isolate and confine the arriving resident, now a PUI, to the BIU, prior to his or her immediate safe transfer to a DOH-designated referral center or guarantine facility for further examination and treatment;

Place the rest of the household under 14-day home confinement. Repeat the process for them, including contact-tracing:

If no symptoms are observed after the 14-day voluntary quarantine, report to the Punong Barangay who will inform the City Health Officer and recommend the lifting of quarantine and certify the PUIs free from COVID-19 infection.

# SECTION 5. PROTOCOLS FOR CONFIRMED CASE/S OF LOCAL TRANSMISSION.

Cases of local transmission Include Filipinos and foreigners residing in the city; To prevent more cases of local transmission and community transmission, the City Mayor shall adopt measures against the possibility of spread of COVID-19, to include but not limited to the following:

- a) Declare State of Calamity if there is a confirmed case of local transmission in the locality, subject to the prescibed guidelines on the declaration of the same.
- b) Direct the Local Disaster Risk Reduction and Management Council to assess the proximity of areas near the city where a confirmed case of local transmission resides or frequents.

The LDRRMC will submit a report to the Local Chief Executive with recommendations for the suspension of classes or work in public offices in the proximity.

- c) Work closely with the Department of Health in conducting contact tracing.
- d) Disseminate to the public the results of contact tracing and areas where the confirmed case frequented and encourage those who may have been in contact with the confirmed case to monitor symptoms of COVID-19 and submit to voluntary testing if symptoms arise.
- e) Direct the BHERT to refer individual persons who are certain to have been in contact with a confirmed case and suffering the symptoms of COVID-19 within 14 days of the confirmation of the disease to undergo mandatory testing.
- Direct the PNP to effect mandatory testing for those confirmed to be in contact with the Ð confirmed case of COVID-19 and showing symptoms within 14 days of the confirmation of the disease, in the unlikely event that the Punong Barangay and the BHERT fail to convince the subject person or persons to voluntarily undergo testing.
- g) Direct the Local Health Office to strictly enforce home quarantine of persons under investigation.
- h) Checkpoints and other means of curtailing the movements of concerned persons, vehicles and animals may be enforced provided the same is for a definite and limited duration of time and due regard is given to the constitutional rights of all individuals.

When directed by the Secretary of Health, the transport and conduction of COVID-19 patients to hospitals or health centers for isolation and treatment shall be allowed and upheld. No arrests and detentions shall be enforced except upon lawful processes emanating from the courts or upon order of quarantine of the Secretary of Health in accordance with law for the purpose of preventing the introduction, transmission or spread of COVID-19.

SECTION 6. OTHER PREVENTIVE MEASURES AGAINST THE SPREAD OF COVID-19. In order to prevent the entry and spread of COVID-19 in the community, the City Mayor shall adopt measures against its spread to include but not limited to the following:

# 1. Prevention and mitigation

- a) Implement periodic precautionary measures such as sanitation, disinfection, and any other measures against the threat and spreading of COVID-19 over:
  - i. all City Government properties and facilities including the respective offices; facilities and properties of the city barangays;

- iii. Public and private schools within city jurisdiction;
- iv. Private businesses within the city jurisdiction:
- v. All national government offices, properties within the city,
- vi. Public Utility Vehicles including motorcabs and trisikad (pot-pot) granted franchise by the LGU transporting passengers to and from Maasin City, Southern Leyte;
- b) Suspension of all crowd drawing government-related events and activities including teambuilding and seminars conducted elsewhere. if any, in collaboration with the City Government;
- c) Conduct of massive information drive to raise the consciousness of the constituents on COVID-19. The information drive may include fliers, leaflets and other information materials on COVID-19 through the help of barangay health workers, other officials and members of the barangay, public and private schools teachers, officials and members of the Sangguniang Kabataan, and members of non-government organizations in the area;
- d) Ensure that only the official information and data provided by the DOH and WHO Philippines are used in advisories, updates and information disseminated on information materials, websites and social media accounts;
- e) Tap the local media in informing the public about COVID-19 and the measures necessary to prevent and contain the disease;
- f) Conduct a city-wide cleanliness and sanitation campaign;
- g) All private business and properties are enjoined to implement their own periodic precautionary measures against the threat of COVID-19
- h) Monitor the prices of medicines and medical devices, and cause the filing of appropriate charges against any person or entity involved in hoarding and/or overpricing.

# 2. Implementing Curfew Hours as Preventive Measure

For the special purpose of preventing the spread of COVID-19 but without repealing City Ordinance No. 2003-17, the following curfew hours and conditions shall be observed:

- a. Persons eighteen (18) years old and above are prohibited to loiter, or wander about in any place, public or private such as but not limited to roads, streets, alleys between ten (10:00) o'clock in the evening and four (4:00) o'clock in the following morning except passengers or incoming or outgoing vehicles such as trucks, jeepneys, motorcabs, trisikad by reason of their business, calling or profession and those given permit by the City Mayor of Maasin, Southern Leyte;
- b. Minors (below eighteen (18) years of age) are prohibited to roam or loiter in public places as afore-mentioned from eight (8:00) o'clock in the evening up to five (5:00) o'clock in the following morning except those given permit by the City Mayor of Maasin City. Southern Leyte;
- c. Persons eighteen (18) years old and above shall be brought to the PNP Station or in an appropriate place provided by the City Government for safekeeping purposes. Provided further, that habitual violators thereof shall be sanctioned a penalty of fine from P500.00 to PhP1,500.00 or imprisonment of arresto menor or both, at the discretion of the court;

d. Minors who violate this curfew hours shall be brought to the PNP Station for safekeeping and proper documentation and thereafter be immediately released to their parents and/or

guardians. Provided further, that the parents and/or guardian of minors habitually violating this Ordinance shall be sanctioned a penalty of PhP 500.00 to PhP1,500.00;

e. The City Mayor by virtue of this Ordinance is hereby authorized to deputize the Punong Barangay, Barangay Kagawad, Barangay Tanod and BHERTs to implement the provision of this ordinance.

#### 3. Containment and control

- a) Organize Barangay Health Emergency Response Teams (BHERTs) at the minimum ratio of one team for every 5,000 population and mobilize them to help implement prevention, mitigation, preparedness, and response measures for the COVID-19;
- b) Provide all medical staff, ambulance crew, BHERT members, and other local health care workers. including PNP and BFP personnel who will potentially be exposed to, or get in direct contact with PUI, with appropriate personal protective equipment;
- Mandatory requirement to all owner/proprietors/administrators of private establishments, including private hospitals, to formulate their own safety measures to protect their employees;
- d) Mandatory requirement to crematorium and/or funeral and embalming establishments to provide for the immediate cremation/burial of any person confirmed or suspected to have died of COVID-19. These establishments are further required to coordinate with the DOH and/or local health authorities in formulating for the safe handling of the remains of persons confirmed or suspected to have died of COVID-19;
- e) Direct all Punong Barangays to identify and designate an appropriate place that will serve as the barangay isolation unit;
- f) Monitor the arrival of barangay residents who recently arrived in the Philippines from a country with a confirmed COVID-19 case and coordinate with the Punong Barangay on actions taken.

**SECTION 7. FUNDING.** The appropriate funding for the implementation of this Ordinance shall be taken from the funds of the City, the Calamity Fund of the City may be utilized subject to the provisions of Republic Act 8185, amending Section 324 (d) of Republic Act 7160, as amended, the City Mayor is hereby authorized to utilize the Calamity Fund, subject to availability of funds and the usual accounting and auditing procedures.

SECTION 8. PROHIBITED ACTS. The following shall be prohibited under this Ordinance:

A. Non-cooperation of persons suspected or identified as having the disease:

- 1 Any person who shall refuse to follow the protocol provided by the DOH with regard to persons confirmed to have COVID-19.
- 2. Any person who refuse to undergo quarantine despite being mandated by the DOH or local health office.
- 3. Any person who shall refuse to observe preventive measures against the spread of the disease as ordered by the local chief executive through the recommendation of the local health office.
- 4. Any health worker who shall negligently perform duties imposed upon him/her by the DOH, local health office or similar institutions.
- Refusal to subject himself to medical examinations or testing that shall be required by the LGU OR DOH as stated in Sections 4 and 5.

- B. Non-cooperation of entities or establishment:
  - 1 Any establishment who neglects to follow the quarantine procedures.
  - 2. Any establishment who refuse to extend appropriate assistance and support to those having the disease.

SECTION 9. PENAL PROVISIONS. Any person or entity who have found to violate the sections on prohibited acts shall be subjected to the following penalties:

- Persons that were confirmed to have COVID-19 shall undergo a mandatory quarantine, or other confinement identified by the DOH. In case of minors, the minors shall be subject to confinement with consent/approval of parents or legal guardians.
- 2. Refusal to follow the protocols despite the issuance of DOH orders & LGU ordinance shall be penalized with a fine of PhP 3,000.00 to Ph 5,000.00
- Establishment owners / proprietors who negligently followed the protocols (medical supplies/ quarantine protocols) shall suffer imprisonment of not exceeding 6 months, or both at the discretion of the court.
- Establishments or entities which refuse or negligently perform the orders of DOH and local health office shall be a subjected to a suspension or have their license revoked upon findings of any violations of this Ordinance.
- 5. Any morgue, crematorium, funeral or embalming establishments offering cremation services which refuse to cremate or embalm any person confirmed to have died from COVID-2019 despite the written permission from the immediate family of the victim or the department of health shall be subject to closure and cancellation of their business and mayor's permit and the owners, proprietors and/or managers of the said establishments shall be penalized with a fine of PhP 3,000 to PhP5,000.00 or an imprisonment for a period of not exceeding one (1) year or both in the discretion of the court.

Jhe Business Permits and Licensing Office shall conduct regular inspections, price control and monitoring activities and may impose administrative fines against erring entities or establishment or recommend prosecution of violation of this ordinance.

 Those persons who purposely and willingly disseminate fraudulent news that caused panic, distress and disturbance of public peace shall suffer a fine of PhP 3,000.00 to PhP 5,000.00 and shall be detained for 12 hours.

SECTION 10. SEPARABILITY CLAUSE. If for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provision hereof, which are not affected, shall continue to be in full force and effect.

SECTION 11. EFFECTIVITY. This ordinance shall take effect upon approval and compliance with the publication and/or posting requirements prescribed under Republic Act No. 7160.

AN ORDINANCE MANDATING THE USE OR WEARING OF FACE MASK OR FACE SHIELD, STRICT OBSERVANCE OF THE PRACTICE OF PHYSICAL DISTANCING AND ESTABLISHMENT OF HANDWASHING STATIONS DURING A DECLARED NATIONAL OR LOCAL PUBLIC HEALTH EMERGENCY, EPIDEMIC OR OUTBREAK OF INFECTIOUS DISEASE AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

The current public health crisis brought by the spread of COVID-19 virus needs to be addressed by national and local governments and they have to devise means to contain the transmission of the same and save lives. The Department of Health protocols enforced by DILG memo mandates the wearing of face masks, observe physical distancing and frequent handwashing whenever outbreaks or epidemics occur to contain or prevent the spread of the infectious disease.

In order to enforce the mandatory wearing of face masks or improvised face shields, observance of proper social distancing, and establishment of handwashing-areas, this Ordinance is passed. We join the whole nation in our move to "Heal As One."

# CITY ORDINANCE NO. 2020-138

AN ORDINANCE MANDATING THE USE OR WEARING OF FACE MASK OR FACE SHIELD, STRICT OBSERVANCE OF THE PRACTICE OF PHYSICAL DISTANCING AND ESTABLISHMENT OF HANDWASHING STATIONS DURING A DECLARED NATIONAL OR LOCAL PUBLIC HEALTH EMERGENCY, EPIDEMIC OR OUTBREAK OF INFECTIOUS DISEASE AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

**BE IT ORDAINED**, by the Sangguniang Panlungsod of the City of Maasin duly assembled in session, that:

**SECTION 1. Title**. – This Ordinance shall be known as the "Mandatory Face Mask Ordinance of the City of Maasin."

# SECTION 2. Definition of Terms:

- 2.1 Infectious Diseases are disorders caused by pathogenic micro organisms, such as bacteria, viruses, parasites or fungi that can be spread directly or indirectly from one individual to another.
- 2.2 Face Mask is a devise worn over the nose and mouth to prevent from spreading germs, may be disposable, washable or reusable.

SECTION 3. Coverage. – It is hereby mandatorily required for any person to wear a protective face mask or face shield and strictly observe the practice of physical distancing at a distance of at least one meter apart, while in public places or public conveyances or work places during the occasion of a declared National or Local Public Health Emergency, epidemic or outbreak of disease, transmissible either orally or through sneezing.

3.1. Handwashing or sanitizing stations shall be established in public places, business establishments, and other places frequented by people.

**SECTION 4.** Responsibility for Parental, Substitute Parental Negligence. – In case the violation of this Ordinance is committed by a minor, the liability for the penalty of fine imposed under the succeeding section shall devolve upon the parents, grandparents, guardian or person who has custody of the minor offender, to be enforced in successive order as herein provided, for the negligence in the exercise of parental or substitute parental authority as the case maybe, over the minor offender, provided however that such minor offender shall be proceeded against under the appropriate intervention program with the applicable provisions of R.A. 9344.

SECTION 5. No Face Mask No Entry in Certain Places. - All Public and Private Institutions and Establishments are mandated to refuse entry to any person not wearing face mask or face shield and shall post notices regarding this requirement.

The President, Manager, or Proprietor of the business establishments or institutions shall be held responsible for the penalty to be imposed for violating the provisions of this section.

SECTION 6. Penalty – Any person, establishment or institution found violating the provision of this Ordinance shall be imposed of the following penalties:

First offense – A fine of Five Hundred Pesos (P500) for Persons and One Thousand Pesos (P1,000) for Establishments and Institutions.

**Second Offense** – A fine of One Thousand Pesos (P1,000) for Persons and Two Thousand Pesos (P2,000) for Establishments and Institutions.

**Third and Succeeding Offenses** – A Fine of Two Thousand Pesos (P2,000) for Persons and Three Thousand Pesos (P3,000) for Establishments and Institutions and/or imprisonment of five to ten days for all violators at the discretion of the court.

**SECTION 7.** Enforcement. – The Philippine National Police, City Traffic Enforcement Office, Healthy City Initiatives Office, and Barangay Officials are hereby tasked to strictly implement the provisions of this Ordinance.

**SECTION 8.** Separability Clause. – If any part or provision of this Ordinance is held constitutionally invalid, other parts or provisions of this Ordinance shall remain in full force and in effect.

**SECTION 9.** Repeating Clause. – All previous ordinances and rules and regulations which are inconsistent with the provisions of this Ordinance are hereby deemed modified or repeated accordingly.

**SECTION 10. Effectivity Clause.** – This ordinance shall take effect upon approval and compliance with the publication and/or posting requirements prescribed under Republic Act No. 7160, but until such time that the declaration of Public Health emergency is lifted.
