RNC-NCR RESOLUTION NO. 01

**RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS TO ADOPT THE
PHILIPPINE PLAN OF ACTION FOR NUTRITION (PPAN) 2017-2022**

WHEREAS, based on the results of the 2015 National Nutrition Survey conducted by the Food and Nutrition Research Institute (FNRI) of the Department of Science and Technology, infants, children, pregnant and lactating women in the National Capital Region are still affected with malnutrition problems;

WHEREAS, these nutritional problems have economic and social costs to the country;

WHEREAS, these problems deprive Filipinos of their right to food and good nutrition;

WHEREAS, the PPAN is the country's blueprint in addressing hunger and malnutrition;

WHEREAS, the PPAN 2017-2022 is designed to reduce the worsening problem of malnutrition particularly wasting, stunting and micronutrient deficiencies and overweight and obesity in the country;

WHEREAS, the PPAN 2017-2022 identified the Nutrition Specific and Nutrition Sensitive Interventions;

WHEREAS, Nutrition Specific interventions address the immediate causes of undernutrition;

WHEREAS, Nutrition Sensitive are interventions that have other objectives but have been tweaked to contribute to nutritional outcomes and enabling strategies;

WHEREAS, while the attainment of nutritional well-being is a main responsibility of families, government organizations and non-government organizations should help the families especially the marginalized, to be able to provide for their own nutritional needs;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED

by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled, enjoins all LGUs in the National Capital Region to adopt the PPAN 2017-2022;
