RNC Resolution No. 01, s 2011

REQUESTING THE RDC THROUGH THE RSDC TO ENJOIN LOCAL GOVERNMENT UNITS (LGUs) TO ADOPT THE IMPLEMENTATION OF THE MEDIUM TERM PHILIPPINE PLAN OF ACTION FOR NUTRITION (MTPPAN) 2011-2016

WHEREAS, The National Nutrition Council (NNC) is the country's policy making, planning and coordinating body on nutrition as mandated by Presidential Decree 491;

WHEREAS, the NNC Regional Office serves as the secretariat of the Regional Nutrition Committee (RNC) that coordinates all nutrition activities and efforts of Local Government Units (LGUs) within the region;

WHEREAS, the RNC coordinates inter-agency nutrition sub-committees which are organized not only at the regional level but also at the provincial, municipal, city and even down to the barangay level for the over-all planning, monitoring and evaluation of the MTPPAN 2011-2016;

WHEREAS, the MTPPAN 2011-2016 embodies the targets, strategies, programs, projects and activities that will be undertaken to ensure good nutrition among Filipinos especially the vulnerable and marginalized;


WHEREAS, the MTPPAN 2011-2016 is integral to the Medium Term Philippine Development Plan (MTPDP) and forms part of the overall response in pursuit of the Millennium Development Goals (MDGs) No. 1 (Eradicate extreme poverty), No. 4 (Reduce infant mortality) and No. 5 (Improve maternal health);

NOW THEREFORE, in view of the above premises, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to concur to the adoption of the MTPPAN 2011-2016;


RESOLVED FINALLY, that the RSDC Secretariat shall provide feedback to the RNC on action taken on this matter;
