RDC Resolution No. 49 s. 2017

ENJOINING ALL CONCERNED REGIONAL LINE AGENCIES AND LOCAL GOVERNMENT UNITS TO SUPPORT THE IMPLEMENTATION OF THE PHILIPPINE PLAN OF ACTION FOR NUTRITION (PPAN) 2017 – 2022

WHEREAS, during the meeting of the National Nutrition Council- Governing Board (NNC-GB) on February 21, 2017, the Philippine Plan of Action for Nutrition (PPAN) for 2017-2022 was approved through Resolution No. 1, Series of 2017 as the country's blueprint to address malnutrition among Filipinos;

WHEREAS, the PPAN 2017-2022 is an integral part of the Philippine Development Plan 2017-2022 and is consistent with the President Duterte Administration's 0 to 10-point Economic Agenda, the Philippine Health Agenda, the development pillars of *malasakit* (protective concern), *pagbabago* (change or transformation), and *kaunlaran* (development) and the vision of *Ambisyon Natin 2040*;

WHEREAS, the PPAN 2017-2022 is one of the country's commitments to the 2025 Global Targets for Maternal, Infant and Young Child Nutrition and the 2030 Sustainable Development Goals particularly the goal on ending hunger, achieving food security and improving nutrition,;

WHEREAS, maternal and child undernutrition continue to be of alarming levels in the Philippines and in Region I as shown in the results of the 2015 National Nutrition Survey (NNS) of the Food and Nutrition Research Institute of the Department of Science and Technology (FNRI-DOST):

Undernutrition Status (in %)	Philippines	Region 1
Stunting	33.4	31.3
Underweight	21.5	19.0
Wasting	7.1	6.6

WHEREAS, the PPAN 2017-2022 consists of programs and projects serving as a framework for actions that could be undertaken at all levels to address the nutritional problems which caused deprivation of Filipinos of their right to food and good nutrition;

WHEREAS, the Regional Nutrition Committee (RNC) as an inter-sectoral body composed of the regional directors/heads of the national government agencies and representatives from the private sector play a vital role in contributing to the attainment of nutrition targets through planning, strong coordination and collaboration of nutrition efforts;

WHEREAS, to respond to the objectives of the Philippine Plan of Action 2017- 2022, the Regional Nutrition Committee, in collaboration with the Provincial/ City Local Government

Units and other stakeholders in nutrition will be conducting a workshop to formulate the Regional Plan of Action for Nutrition;

WHEREFORE, upon the recommendation of the Regional Social Development Committee (RSDC) through RSDC Resolution No. 4, s. 2017 and on motion duly seconded,

BE IT RESOLVED, as it is **HEREBY RESOLVED**, to enjoin all concerned Regional Line Agencies and Local Government Units to support the implementation of the Philippine Plan of Action for Nutrition (PPAN) 2017 - 2022.

RESOLVED FURTHER, to enjoin all Local Governments to formulate or reformulate their three-year local nutrition action plans along the PPAN programs and in consideration to the locality's nutrition problems and causes.


RESOLVED FURTHER, to request the Department of the Interior and Local Government to monitor the Local Government Units' compliance and actions to this resolution.




