**Approving the submission to the Office of the President of the nomination of the Philippine Coalition of Advocates for Nutrition Security Inc. (PhilCAN), the Philippine Legislators' Committee on Population and Development (PLCPD), and the Union of Local Authorities of the Philippines (ULAP) as private sector representatives to the NNC Governing Board**

**WHEREAS**, Executive Order No. 234 issued in 1987 reorganized the National Nutrition Council and provided for, among others, the membership of three private sector representatives to the NNC Governing Board as appointed by the President of the Philippines for a two-year term;

**WHEREAS**, the new administration heralds a fresh start with a new set of members of the NNC Governing Board, and in compliance with the mandate of NNC under EO 234, there is a need to submit a set of nominees of private sector representatives to the Office of the President;

**WHEREAS**, the Implementing Guidelines of EO 234 indicate the following criteria for the selection of the private sector representatives: 1) Nationwide coverage, 2) With programs that are consistent with the priorities of the national nutrition plan/program, 3) Targets priority population groups of the national nutrition plan/program;

**WHEREAS**, the selection of the private sector representatives addresses the need to strengthen linkages with organizations that have a proven track record in supporting food and nutrition security programs at the grassroots level, as well as those that work with local government units, and along policy and legislative advocacy;

**WHEREAS**, the appointment of the Union of Local Authorities of the Philippines (ULAP), as private sector representative to the NNC Governing Board while effective up to 2017 was terminated because of OP MC 04 that called for the courtesy resignation of presidential appointees and, as such, there is a need to renew its nomination as one of the three private sector representatives of the NNC Governing Board;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to recommend to the Office of the President the following organizations as private sector representatives and members of the NNC Governing Board: 1) Philippine Coalition of Advocates for Nutrition Security, Inc, a network of civil society organizations (CSOs) involved in programs and projects along food security, nutrition, health, and social welfare; 2) Philippine

Legislators' Committee on Population and Development, a membership-type organization of legislators from the Senate and House of Representatives involved in generating viable, responsive, and people-centered public policies on population and human development; and 3) Union of Local Authorities of the Philippines, an umbrella organization of all leagues of local government units, and the leagues and federations of local elective and appointive officials in the Philippines.

**RESOLVED FURTHER** for the National Nutrition Council Secretariat to attend to the preparation of the needed documents for the nomination, and to follow-through needed actions in close coordination with the Office of the President.

**RESOLVED FURTHER** that should there be changes in the person appointed by the organization as official representative to the NNC Governing Board after the submission of documents to the Office of the President, the Chair of the NNC Governing Board is authorized to submit the name of the new representative without need for another NNC Governing Board resolution.
