**Resolution No. 01 Series of 2020**

**RESOLUTION ADOPTING THE**  
**REGIONAL PLAN OF ACTION FOR NUTRITION CY 2019 - 2022**

**WHEREAS**, malnutrition continues to affect a significant number of population in Davao Region, as reported by the 2018 Expanded National Nutrition Survey (ENNS) conducted by DOST- Food and Nutrition Research Institute;

**WHEREAS**, these nutritional problems have economic and social costs to the region and the country, depriving Filipino citizens of their right to food and good nutrition;

**WHEREAS**, the Regional Nutrition Committee members, through a planning workshop and a series of consultation meetings, formulated a Regional Plan of Action for Nutrition for CY 2019 – 2022 to address the malnutrition problem in the Region.

**WHEREAS**, the key characteristics of the plan are 1) results-based, with clear agency accountabilities; 2) ambisyon 2040 as overall framework; 3) integral to the Philippine Development Plan 2017-2022; 4) Integral to the All for Health towards Health for All Agenda; and 5) contributes to Sustainable Development Goals;

**WHEREAS**, the RPAN includes 1 nutrition-sensitive, 1 enabling and 9 nutrition-specific programs following the life stages of the Department of Health and the major programs of the Philippine Plan of Action for Nutrition 2017-2022, with one additional program to reflect the huge challenge of adolescent health.

**WHEREAS**, the plan recognizes that although the attainment of nutritional well-being is a main responsibility of families, the duty bearers like government organizations and nongovernment organizations should help the families, especially the marginalized, to enable them to provide for their own nutritional needs;

**WHEREAS**, the RPAN outcomes and outputs are essentially a regional accountability with results matrix explicit in the accountabilities of each of the agencies in the region.

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, in consideration of the foregoing, we, the Regional Nutrition Committee of Davao as the region's policy-making body on nutrition do hereby adopt the RPAN 2019 – 2022;

**RESOLVED FURTHER**, that we, the RNC member agencies and organizations commit to:

1. Pursue the programs and projects herein specified and continue to identify measures and strategies to adapt to the “New Normal” during the plan's implementation.
