INVITATION FOR NEGOTIATED PROCUREMENT DUE TO TWO-FAILED BIDDINGS

SUPPLY AND DELIVERY TO CONSIGNEES OF NUTRIBUN FOR THE NNC'S "TUTOK KAINAN" DIETARY SUPPLEMENTATION PROGRAM FOR PREGNANT WOMEN IN THE MUNICIPALITIES OF LANAO DEL SUR AND LANAO DEL NORTE - PHASE 5

- 1. The NATIONAL NUTRITION COUNCIL (NNC), through the General Appropriations Act (GAA)-Early Childhood Care and Development in the First 1000 days intends to apply the sum of Two Million Three Hundred Eighty Five Thousand One Hundred Eighty Pesos only (Php 2,385,180.00) being the total Approved Budget for the Contract (ABC) to payments under the contract for the Supply and delivery to consignees of Nutritbun for "Tutok Kainan" Dietary Supplementation Program for Pregnant Woman in the Municipalities of Lanao del Sur and Lanao del Norte Phase 5. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Nutrition Council now invites bids for the Supply and delivery to consignees of Nutribun for "Tutok Kainan" Dietary Supplementation Program for Pregnant Woman in the Municipalities of Lanao del Sur and Lanao del Norte Phase 5. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. No. 5183.

The procurement procedure for this requirement is Negotiated Procurement pursuant to Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act", including Annex "H" thereof.

The NNC-BAC will engage in negotiations with a sufficient number of suppliers to ensure effective competition. The selection of the successful offer shall be based on the best and final offer that will be submitted on the specified date shown below, and which would meet the minimum technical specifications required.
