Addendum No. 0-2021 modifies or amends in the Technical Specifications of the Bidding Documents issued on 27 January 2022 for the Provision of Security Services for the National Nutrition Council - Central Office for CY2022. This shall form an integral part of the bidding documents.

- 1. Bidders shall adopt the 4% deduction for PhilHealth contribution and shall be reflected in the Bid Proposal.
- 2. Standard Administrative Overhead and Margin shall be uniform at twenty percent (20%) of the total contract cost.
- 3. Bidders are required to submit PNP SOSIA Certificate as part of the technical document.
- 4. All original documents required in the checklist shall be put in the Original Bid folder/envelope, while all photocopied documents shall be marked and certified bearing the "certified true copy" by the authorized records custodian of the security agency. Envelopes 1, 2, and 3 shall contain photocopies of document inside the original bid envelope.
- 5. Bidders shall bid only for ten (10) months (March December 2022).
