EXCERPT FROM THE MINUTES OF THE 4th REGULAR REGIONAL DEVELOPMENT COUNCIL (RDC)-1 MEETING FOR CY 2019 HELD ON 28 NOVEMBER 2019 AT LINGAYEN, PANGASINAN

RDC-1 Resolution No. 101, s. 2019

APPROVING AND ADOPTING THE REGIONAL PLAN OF ACTION FOR NUTRITION (RPAN) 2019-2022 AND ENJOINING ALL REGION 1 LOCAL GOVERNMENT UNITS (LGUS), ACADEME, CIVIL SOCIETY ORGANIZATIONS (CSOS) AND NON-GOVERNMENT ORGANIZATIONS (NGOS) TO SUPPORT ITS IMPLEMENTATION

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) 2017-2022 is an integral part of the Philippine Development Plan 2017-2022 that serves as the overall framework to address the nutritional problems of Filipinos;

WHEREAS, the PPAN 2017-2022 was adopted in the region through RDC Resolution No. 49 s. 2017 entitled "Enjoining All Concerned Regional Line Agencies and Local Government Units (LGUs) to Support the Implementation of the Philippine Plan of Action for Nutrition (PPAN) 2017-2022";

WHEREAS, the same resolution stated that the Regional Nutrition Committee (RNC)-1 in coordination with the LGUs and other stakeholders will formulate the Regional Plan of Action for Nutrition (RPAN) to respond to the objective of the PPAN 2017-2022;

WHEREAS, RNC-1 conducted workshops with member agencies and LGUs in January 2019 for the formulation of Region 1 RPAN 2017-2022;

WHEREAS, the formulated RPAN 2019-2022 contains key elements expected to contribute to the attainment of the national goals and targets with programs and projects as the response of Region 1 to the nutritional problems in the region such as prevalence of malnutrition and increasing incidents of non-communicable diseases (NCD), among others;

WHEREAS, the RPAN also embodies the commitment and accountabilities of the RNC member agencies as a contribution of the region to the proportionate share of the malfunction burden in the country and provides estimated budget requirements for each of the identified programs and projects;

WHEREAS, during the 4th Regular Regional Social Development Committee (RSDC)-1 Meeting on November 26, 2019, the body endorsed the resolution requesting the Regional Development Council-1 (RDC-1) to approve and adopt RPAN 2019-2022, and enjoin Region 1 Local Government Units (LGUs), Academe,



Civil Society Organizations (CSOs) and Non-government Organizations (NGOs) to support its implementation;

NOW, THEREFORE, FOR AND IN CONSIDERATION OF THE ABOVE PREMISES, BE IT RESOLVED, as it is HEREBY RESOLVED to approve and adopt the Regional Plan of Action for Nutrition (RPAN) 2019-2022;

RESOLVED FURTHER, to enjoin all Region 1 Local Government Units (LGUs), Academe, Civil Society Organizations (CSOs) and Non-Government Organizations (NGOs) to support the implementation of the RPAN 2019-2022;

RESOLVED FURTHER, to request the Regional Nutrition Committee (RNC)-1 to monitor the Plan implementation and conduct annual review of the plan;

RESOLVED FURTHER, that the NNC Regional Office I being the secretariat of the RNC-1 to present quarterly accomplishment reports to the RSDC-1 and annual report to the RDC-1 during their meetings;

RESOLVED FINALLY, to provide copies of this resolution to all members of the RDC-1 and its Sectoral, Support and Sub-committees for their information;
