## Regional Nutrition Committee (RNC) Resolution No. 4, s. 2021

## ADOPTING THE SCALING-UP NUTRITION (SUN) 3.0 STRATEGY IN REGION I AND ORGANIZATION OF SUN MOVEMENT NETWORKS

WHEREAS, the Scaling-Up Nutrition (SUN) Movement envisions a world free from malnutrition in all its forms by 2030, led by the governments and supported by organizations and individuals through collective actions to ensure that every child, adolescent, mother and family can realize their right to food and nutrition, reach their full potential and shape sustainable and prosperous societies;

WHEREAS, having the same vision, the Philippines joined the (SUN) Movement through the National Nutrition Council Governing Board (NNC GB) Resolution No. 2, s. 2014, the 51<sup>st</sup> country to do so;

WHEREAS, the Philippines' SUN Movement organized networks for civil society, development partners, businesses, and academe to work collectively and in collaboration to improve country's nutrition situation and to push for the realization of the Philippine Plan of Action for Nutrition (PPAN);

**WHEREAS**, the SUN 3.0 strategy of the Movement was nationally launched on June 4, 2021, and calls for its expansion down to the sub-national level to ensure more sectoral engagement and investment for nutrition;

WHEREAS, the SUN 3.0 strategy was designed to further accelerate the achievement of nutritional goals such as the World Health Assembly targets by 2025, and Sustainable Development Goals (SDGs) by 2030, particularly on eradicating extreme poverty and hunger. This is consistent with the international and national commitments from the previous strategies of the movement;

WHEREAS, the strategy identifies interventions with proven positive impact, as it emphasize providing mothers and families the support they need to carry out their crucial roles, and it explicitly defines the obligations and responsibilities of the government and other organizations and agencies;

WHEREAS, the Regional Nutrition Committee of Region 1 recognizes the vital roles of organizations such as the Academe, Civil Society Organizations (CSOs)/Non-Government Organizations (NGOs) And Business Sectors in Region 1 working together and establish a more multisectoral coordination in the planning, implementation and monitoring of nutrition activities for improved nutrition in the region;

WHEREAS, malnutrition may exacerbate the impacts of the COVID-19 as it had set new threats to the nutrition situation of a community, making it more prominent for all localities and sectors to invest in nutrition as one of the key element of building human capital and essential to achieving the Sustainable Development Goals (SDGs) particularly on Zero Hunger;

NOW THEREFORE, FOR AND IN CONSIDERATION OF THE ABOVE PREMISES, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Regional Nutrition Committee of Region 1 on its meeting duly assembled to adopt Scaling Up Nutrition 3.0 Strategy and organize SUN Movement Networks; **RESOLVED FURTHER**, to request the National Nutrition Council-Regional Office I to convene and orient potential partners and organize networks for academe, civil society organizations and business networks to push for PPAN implementation in Region 1;

**RESOLVED FURTHER**, to request the presidents or chairpersons of the networks to be members of the Regional Nutrition Committee of Region 1 and attend to all of its endeavors;

**RESOLVED FINALLY**, to provide a copy of this resolution to all concerned entities for information, reference and dissemination;

**APPROVED UNANIMOUSLY**, this 29<sup>th</sup> day of June 2021 during the 1<sup>st</sup> semester meeting of the Regional Nutrition Committee of Region I held via zoom.
