REGIONAL NUTRITION COMMITTEE X Resolution No. <u>1</u>, s. 2021

EXPANDING THE MEMBERSHIP OF THE REGIONAL NUTRITION COMMITTEE X TO INCLUDE THE ADVENTIST MEDICAL CENTER COLLEGE (AMCC) AND CENTRAL MINDANAO UNIVERSITY (CMU)

- WHEREAS, the Regional Nutrition Committee (RNC) X is Northern Mindanao's inter-agency governing board on nutrition policy, planning, monitoring, evaluation, and advocacy;
- WHEREAS, at present, the RNC X is made up of 27 members composed of 22 regional line agencies, one non-government organization, one academe and three local nutrition workers' regional associations;
- WHEREAS, there are three universities and colleges in the region offering BS Nutrition and Dietetics, namely, Adventist Medical Center College of Iligan City, and Central Mindanao University of Maramag, Bukidnon, together with Lourdes College of Cagayan de Oro City which is already a member of the RNC X;
- WHEREAS, there is a need to reinforce the local research background to strengthen the policymaking function of the RNC X to address the needs of the constituents of Region 10;
- WHEREAS, the RNC X acknowledges the need to maximize partnerships with universities and colleges with bachelor's degree program in Nutrition and Dietetics as training grounds for future community Nutritionist-Dietitians;
- WHEREAS, the above-mentioned institutions have continually supported the nutrition policies, plans and programs of the national government;
- WHEREAS, the representation of AMCC and CMU to the RNC X is deemed important to further fortify the composition of the committee.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, on a motion duly seconded that the membership of the RNC is hereby expanded to include Adventist Medical Center College and Central Mindanao University represented by the Chairpersons of the institutions' Departments on Nutrition and Dietetics;

RESOLVED FURTHER, that both institutions will execute the functions of an RNC member, with additional specific responsibilities as academe representatives:

- 1. Prepare and provide inputs to the regional plans, policies and programs, including the Regional Plan of Action for Nutrition;
- 2. Implement nutrition and related programs based on agency mandates and commitments in the PPAN;
- 3. Coordinate the planning, monitoring & evaluation of the regional nutrition program, as appropriate;
- 4. Monitor local government performance, assess progress of plan implementation, and recommend appropriate actions;
- 5. Provide technical assistance to LGUs along with nutrition program management;

- Participate in nutrition activities of the RNC X and its structures, such as but not limited to regular meetings, Program Implementation Review, monitoring and evaluation activities, Nutrition Month campaign and other initiatives;
- 7. Share reports and other inputs to the RNC X/Secretariat as needed;
- 8. Integrate developments and updates on nutrition programs in the subject course;
- 9. Share conducted research on health and nutrition; and
- 10. Cascade nutrition information and updates to the school/students.

RESOLVED FINALLY, that the NNC Region X being the Secretariat of the RNC X to furnish all members of the RNC, including AMCC and CMU, a copy of this Resolution and all concerned entities for support as well as to ensure their active participation.
