## REGIONAL NUTRITION COMMITTEE X Resolution No. <u>10</u>, s. 2021

## ADOPTING THE SCALING UP NUTRITION (SUN) MOVEMENT IN REGION X

WHEREAS, the Scaling Up Nutrition (SUN) Movement is a United Nations (UN)-established movement, which calls for accelerated results to eliminate all forms of malnutrition by 2030;

WHEREAS, in 2014, the Philippines became the 51st country to join the SUN Movement;

- WHEREAS, the National Nutrition Council Governing Board approved the Philippine registration to the SUN Movement to gain support from other SUN member countries and international development partners, and the UN agencies in improving the nutrition situation of the country and in harmonizing strategies to ensure effective implementation in order to achieve nutrition targets;
- WHEREAS, the NNC Regional Office 10 organized the SUN Network at the sub-national level last 7 September 2021, to intensify nutrition actions to achieve results and for synergy in terms of priorities for action, and greater accountability and collaboration;
- WHEREAS, the network was also organized to gain stakeholders' support to invest and sustain nutrition and nutrition-related interventions, as well as to harmonize and streamline these efforts to achieve goals for nutrition, which will eventually contribute, to the achievement of the goals of the Philippine Plan of Action for Nutrition;
- WHEREAS, the Regional Nutrition Committee (RNC) of Region 10 recognizes the vital roles of organizations such as the Academe, Civil Society Organizations (CSOs), and the Business Sectors in scaling up efforts on nutrition;
- WHEREAS, the COVID-19 pandemic may exacerbate the impacts of malnutrition as it had set new threats to the nutrition situation of the community; needing scaled up nutrition actions to end all forms of malnutrition to realize the vision of a country without hunger and malnutrition.

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** by the RNC X in a meeting duly assembled, upon recommendation of the RNC Technical Working Group, adopts the Scaling Up Nutrition (SUN) Movement in Region X;

**RESOLVED FURTHER**, that as members of the RNC X, we commit our departments to fully support the implementation and developments of the movement;

**RESOLVED FINALLY**, for the National Nutrition Council Regional Office X as Secretariat of the RNC to cause the widest dissemination of the organization of the "*Scaling Up Nutrition (SUN) Movement*" by furnishing all the member agencies of the RNC, the local government units, other regional partners and the National Nutrition Council Secretariat a copy of this Resolution.
