REGIONAL NUTRITION COMMITTEE X Resolution No. <u>3</u>, s. 2022

INCLUSION OF THE REGIONAL SCALING UP NUTRITION (SUN) NETWORK CONVENORS AS MEMBERS OF THE EXPANDED REGIONAL NUTRITION COMMITTEE X

- WHEREAS, the Regional Nutrition Committee (RNC) X is Northern Mindanao's inter-agency governing board on nutrition policy, planning, monitoring, evaluation, and advocacy;
- WHEREAS, the RNC X acknowledges the need to maximize partnerships to gain support from other stakeholders in improving the nutrition situation of the region and the country as a whole and in harmonizing strategies to ensure effective implementation in order to achieve nutrition targets;
- WHEREAS, the Scaling Up Nutrition (SUN) Movement is a United Nations (UN)-established movement, which calls for accelerated results to eliminate all forms of malnutrition by 2030;
- WHEREAS, the NNC Regional Office 10 organized the SUN Network at the sub-national level last 7 September 2021, to intensify nutrition actions to achieve results and for synergy in terms of priorities for action, and greater accountability and collaboration;
- WHEREAS, the RNC of Region 10 recognizes the vital roles of organizations such as the Academe, Business Sectors, and the Civil Society Alliance (CSA) in scaling up efforts on nutrition through the RNC X Resolution No. 10, s. 2021 entitled "Adopting the Scaling Up Nutrition (SUN) Movement in Region X" approved last 19 October 2021;
- WHEREAS, the representation of the SUN Networks to the RNC X is deemed important to further reinforce the composition of the committee;
- WHEREAS, the said three new members shall be invited in the next meeting of the RNC to be introduced as one of the official members of the RNC;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, on a motion duly seconded that the RNC X shall include the SUN Networks represented by the Convenors per network in the expanded committee membership;

RESOLVED FURTHER, that the SUN Networks in Northern Mindanao, being members of the RNC X, are expected to perform the following functions:

- 1. Prepare and provide inputs to the regional plans, policies and programs, including the Regional Plan of Action for Nutrition;
- 2. Implement nutrition and related programs based on organizational mandates and commitments in the PPAN;
- 3. Coordinate the planning, monitoring & evaluation of the regional nutrition program, as appropriate;
- 4. Monitor local government performance, assess progress of plan implementation, and recommend appropriate actions;
- 5. Provide technical assistance to LGUs along with nutrition program management;

- Participate in nutrition activities of the RNC X and its structures, such as but not limited to regular meetings, Program Implementation Review, monitoring and evaluation activities, Nutrition Month campaign and other initiatives; and
- 7. Share reports and other inputs to the RNC X/Secretariat as needed.
