Excerpts from the Minutes of the 77th Regular Meeting of Regional Development Council (RDC) XII on June 23, 2022, via videoconference.

RDC XII Resolution No. 44, series of 2022

ADOPTING THE IMPLEMENTING GUIDELINES ON NUTRITION SHEPHERDING PROJECT FOR EFFECTIVE NUTRITION PROGRAM MANAGEMENT

- **WHEREAS,** the nutrition program management is a decision-making process of identifying potential nutrition problems of specific population groups and identifying key interventions or strategies and programs/projects to prevent and control malnutrition.
- WHEREAS, to facilitate effective nutrition program management under the enabling mechanism of the Philippine Plan of Action for Nutrition (PPAN), the National Nutrition Council has set up a technical assistance platform dubbed as Nutrition Shepherding Project (NSP), which provides a platform for guiding and mentoring low performing local government units (LGUs) by a regional nutrition shepherding team to enhance their knowledge and skills on nutrition program management;
- **WHEREAS,** in the implementation of the said intervention, the NSP shall promulgate the 7-step guidelines, namely:
 - 1) Secure policy support of relevant regional policy-making bodies;
 - 2) Organize, capacitate, and mobilize the Regional Nutrition Shepherding Team;
 - 3) Advocate the program;
 - 4) Secure agreement and engagement of the priority LGU;
 - 5) Set-up online platform and IT support;
 - 6) Deploy the Regional Nutrition Shepherding Team; and,
 - 7) Implement monitoring and evaluation system.
- **WHEREAS,** the target LGUs for the NSP in 2022 are the municipalities of Arakan in Cotabato and Senator Ninoy Aquino in Sultan Kudarat, and coordination and initial assessment of their nutrition performance is now on-going;
- **WHEREAS,** the newly created Regional Nutrition Shepherding Team in Region XII, with the cooperation of the member agencies, shall be strengthened to provide the needed technical assistance in improving the nutrition program management skills of target LGUs and the region in general;
