### **RDC XII Resolution No. 45, series of 2022**

#### **ADOPTING THE SCALING UP NUTRITION (SUN) 3.0 STRATEGY AND THE ORGANIZATION OF THE REGIONAL SUN MOVEMENT IN THE SOCCSKSARGEN REGION**

**WHEREAS**, the Scaling Up Nutrition (SUN) 3.0 strategy is the third phase of the United Nations established movement that calls for accelerated results to eliminate all forms of malnutrition by 2030;

**WHEREAS**, NNC Governing Board Resolution No. 2 was issued in April 2014 for the Philippines to join the SUN Movement and in 2019, National Nutrition Council Executive, Director Azucena M. Dayanghirang, was designated as SUN-Philippines Focal Point, and is now a member of the Executive Committee of the Global SUN Movement for Asia and Papua New Guinea;

**WHEREAS**, guided with the common vision to end all forms of malnutrition, the Philippines' commitment to the SUN Movement is best outlined in the Philippine Plan of Action for Nutrition (PPAN) with its programs and initiatives on nutrition specific, nutrition sensitive with corresponding enabling mechanisms:

**WHEREAS**, SOCCSKSARGEN Region echoes parallel commitment as stated in the Regional Plan of Action for Nutrition (RPAN) 2019-2022 as high malnutrition prevalence remains a public health concern in the region; and NNC XII will spearhead the organization of the Regional SUN Movement in support of the said commitment;

**WHEREAS**, the SUN 3.0 strategy focuses on results and outcomes and expanding its effort to undernutrition including overweight and obesity:

**NOW, THEREFORE**, on motion of Mr. Jose Ronie V. Mondragon, Private Sector Representative for the Labor Sector, and duly seconded by Assistant Regional Director for Operations Bonifacio V. Selma, Jr., of Department of Social Welfare and Development XII, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, That RDC XII adopt the Scaling Up Nutrition (SUN) 3.0 strategy and the organization of regional SUN movement in SOCCSKSARGEN Region.
