Central Luzon Regional Nutrition Committee Resolution No. 2 Series of 2020

## EXPANDING THE MEMBERSHIP OF THE CENTRAL LUZON REGIONAL NUTRITION COMMITTEE

- WHEREAS, the National Nutrition Council was created under Presidential Decree 491 series of 1974, otherwise known as Nutrition Act of the Philippines;
- WHEREAS, Section 5 of PD 491 stipulated the important functions and powers of the Council such as: *a*) To formulate an integrated national program on nutrition; *b*) To supervise, coordinate and evaluate the implementation of the integrated Philippine Food and Nutrition Program (now called the Philippine Plan of Action for Nutrition) to be implemented by all agencies and instrumentalities of both the government and the private sector concerned with improving the nutrition of the Filipino people and *c*) to coordinate and integrate policies and programs of all agencies and instrumentalities of the government charged with the prosecution of existing law, policies, rules and regulations concerning nutrition, among others;
- WHEREAS, the structure and functions of the Council at the national level is replicated at the geo-administrative levels as regional, provincial, city, municipal and barangay nutrition committees;
- WHEREAS, Regional Nutrition Committee Resolution No. 4 Series of 2014 re-organized the Regional Nutrition Committee for Central Luzon to perform additional functions as Regional *Bantay Asin* Task Force and Regional Nutrition Cluster;
- WHEREAS, the Central Luzon Regional Nutrition Committee formulated the Regional Plan of Action for Nutrition (RPAN), 2019-2020 which consisted of nutrition sensitive, nutrition enabling and nutrition specific programs that are anchored on the life stages programs of the Department of Health and the major programs of the Philippine Plan of Action for Nutrition 2017-2022;
- WHEREAS, as a response to the nutrition problems identified in the planning process, the Department of Agrarian Reform-Regional Office III actively took part during the formulation of the RPAN, 2019-2020 and identified significant number of nutrition-sensitive programs which seek to target food insecure households to enable them to improve their livelihood and gain employment in order to have physical access to food daily;

WHEREAS, the CL RNC members agreed to expand its membership in order to improve organizational effectiveness and efficiency and to further respond to the achievement of the nutritional goals of the RPAN, 2019-2022 and improvement in the nutrition situation in the region;
