15th RDC III Resolution No. 03-30-2019

ADOPTING THE CENTRAL LUZON REGIONAL PLAN OF ACTION FOR NUTRITION (RPAN) 2019-2022

- WHEREAS, malnutrition is a condition that is due to lack, excess or imbalance in one or more nutrients, usually in the following major forms: stunting, wasting, and overweight/obesity;
- WHEREAS, in Central Luzon, stunting is a major problem in Aurora while overweight children is highest among other regions;
- WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) 2017-2022 is the country's blueprint in achieving improved nutrition and serves as the framework for nutrition action;
- WHEREAS, the PPAN 2017-2022 contributes to the attainment of the goals of the Philippine Development Plan, the Sustainable Development Goals, and in the long term, the Ambisyon Natin 2040;
- WHEREAS, one of the strategies to fully operationalize the PPAN 2017-2022 is the formulation of a Regional Plan of Action for Nutrition (RPAN);
- WHEREAS, RPAN 2019-2022 was formulated through a participatory, inter-sectoral and multi-level process;
- WHEREAS, the Central Luzon RPAN contains key elements expected to contribute to the attainment of the PPAN 2017-2022 national goals and targets;
- WHEREAS, in full recognition of the nutritional problems and its dimensions, the Central Luzon RPAN 2019-2022 identified a mix of interventions appropriate for the region consisting of three distinct but complementing types of programs: nutrition-specific, nutrition-sensitive, and enabling management programs as defined in the PPAN program framework;
- WHEREAS, the Central Luzon Regional Nutrition Committee during its meeting on 9 January 2019 approved the RPAN 2019-2022, and agreed to initiate efforts leading to the implementation of its programs, projects and activities;

WHEREAS, the RDC III found merit on the development strategies of RPAN 2019-2022 and agrees to adopt the same; 15th RDC III Resolution No. 03-27-2019, Page 1 of 2
