RDC RESOLUTION NO. IV-A-56-2021

"ENDORSING THE LEARNING HUB ON ENHANCED AND REVITALIZED NUTRITION PROGRAM AND LGU SHEPHERDING PROGRAM ON LOCAL NUTRITION GOVERNANCE FOR ADOPTION AND SUPPORT OF THE LGUS AND RDC MEMBERS"

- **WHEREAS,** the Philippine Plan of Action for Nutrition (PPAN) 2017-2022 and the Regional Plan of Action for Nutrition 2019-2022 are the national and regional policy frameworks on addressing all forms of malnutrition;
- WHEREAS, the National Nutrition Council Governing Board approved through Resolution No. 5 series of 2019 the local government units' (LGU) Mobilization Strategy for PPAN 2017-2022 to scale up efforts of mobilizing LGUs in achieving desired nutrition outcomes by increasing the number of LGUs that implement quality nutrition programs and interventions nationwide;
- WHEREAS, the mobilization strategy adopts a three-pronged peer-learning approach on capacitating LGUs for improved nutrition program management namely:
 1) Learning Hub for Enhanced and Revitalized Nutrition (LHEARN) Program;
 2) LGU Shepherding Program; and 3) Nutrition Champions Program;
- WHEREAS, the CALABARZON Region was selected as a pilot area for the establishment and operationalization of the LHEARN Program and the first recipient of the Training on LGU Shepherding Program;
- WHEREAS, the Sectoral Committee on Social Development/Social Protection during its third quarter meeting on August 10 endorsed to the RDC the adoption of the LHEARN Program and the LGU Shepherding Program, and to enjoin the LGUs and RDC members in the Region to support these peer to peer learning approaches;
- NOW THEREFORE, on motion duly seconded, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to endorse the learning hub on enhanced and revitalized nutrition program and shepherding program on local nutrition governance for adoption and support of the LGUs and RDC members.
