1. **Prefatory Statement**

The Comprehensive Development Plan (CDP) Guide, based on the 2008 sourcebook on Rationalizing the Local Planning System (RPS), established the tools, processes, and techniques to help assist local government units (LGUs) in the formulation and preparation of CDPs. Said Guide was formulated in the wake of the issuance of DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 20071 (JMC No. 2007-01), that delineated responsibilities of national government agencies (NGAs) for providing assistance in planning to LGUs.

The CDP contains the six-year strategic direction and developmental priorities of an LGU. It covers five (5) development sectors: social, economic, infrastructure, environmental, and institutional, providing a convergence mechanism to integrate or derive NGA-mandated plans and other sectoral/thematic plans [e.g. Local Climate Change Action Plan (LCCAP), Local Disaster Risk Reduction and Management Plan (LDRRMP), and Peace and Order Public Safety Plan (POPS Plan)].

To further enhance and strengthen linkages in planning, budgeting, and resource mobilization, DILG-NEDA-DBM-DOF JMC No. 1 Series of 2016² (JMC No. 2016-01) that amended JMC No. 2007-1 was issued to prescribe new and updated policies, systems, and tools on public financial management (PFM) as it highlighted shared oversight functions of the national and provincial governments; acknowledged the need to strengthen vertical and horizontal alignment of national and local plans; and introduced provincial review of CDPs of component cities and municipalities.

This is consistent with the intent of the Special Provisions stipulated in Republic Act No. 10924 or the General Appropriations Act (GAA) of FY 2017³ and Republic Act No. 10964 or the GAA of FY 20184 that sought to increase functionality of Local Development Councils (LDCs) and responsiveness of national government assistance to LGUs by ensuring that national and local strategic priorities and thrusts are aligned.

To further strengthen alignment of plans and provincial oversight functions, the Department is sustaining its initiative to institutionalize the CDP Assessment Tool, prescribed in JMC No. 2016-01, as an instrument to evaluate compliance of component cities and municipalities to: (i) the prescribed forms and processes of CDP formulation, (ii) alignment of the CDP and Local Development Investment Program (LDIP) with the Provincial Development and Physical Framework Plan (PDPFP),

Provincial Development Investment Program (PDIP) and Comprehensive Land Use Plan (CLUP), and (iii) the integration of sector/thematic concerns in the CDP.

2. Purpose

This Memorandum Circular (MC) intends to:

- Emphasize the role of the province in local development planning and as oversight partner of the national government over its component cities and municipalities;
- Provide guidance to provinces/concerned Sangguniang Panlungsod/Bayan in assessing adherence of component cities and municipalities to the prescribed guidelines and processes on CDP formulation/updating;
- Strengthen the relationship of the Province and its component cities and municipalities as partners in local development by facilitating plan complementation and augmentation between the PDPFP and PDIP of provinces and CDPs of component cities and municipalities; and,
- Emphasize the importance of evidence-based planning.

The province may develop and undertake joint programs or augment the financial resources of its component cities and municipalities in implementing programs and projects that have significant impacts on the province as a whole. The assessment results can also serve as basis for performance and compliance evaluation by NGAs and development partners for LGUs to access grants and other assistance.

3. Legal Compliance

- 3.3. DILG-NEDA-DBM-DOF JMC No. 1 Series of 2016 Updated Guidelines on the Harmonization of Local Planning, Investment Programming, Resource Mobilization, Budgeting, Expenditure Management, and Performance Monitoring and Coordination in Fiscal Oversight, dated 18 November 2016
- 3.4. DILG MC No. 2008-156 Guide to Comprehensive Development Plan (CDP) Preparation for Local Government Unit, dated 22 October 2008
- 3.5. DILG MC No. 2010-112 LGU Compliance to Updating and Legitimization of Comprehensive Land Use Plan (CLUP) and Comprehensive Development Plan (CDP), dated 12 October 2010
- 3.6. DILG MC No. 2016-102 Guidelines on the Preparation or Updating of Local Plans, dated 08 August 2016

4. Scope/Coverage

This MC covers all Provincial Governors, Component City/Municipal Mayors, DILG Regional and Provincial Directors, Sangguniang Panlalawigan/Panlungsod/Bayan, Provincial/City/Municipal Development Councils (R/P/C/MDCs), Provincial/City/Municipal Planning and Development Coordinators (P/C/MPDCs), and others concerned.

5. Definitions

- 5.1. Comprehensive Development Plan (CDP) the document that pertains to the multi-sectoral plan formulated at the city or municipal level, which embodies the vision, sectoral goals, objectives, development strategies, and policies within the terms of LGU officials and the medium-term. The CDP contains: (i) Ecological Profile, (ii) Sectoral Development Plan, and (iii) Implementing Instruments.⁵
- 5.2. Comprehensive Development Plan Assessment Tool also known as the CDP Review Guide as stipulated in JMC No. 2016-01, a tool by the DILG for the assessment of approved CDPs of component cities and municipalities by their respective provinces issued in the Local Planning Illustrative Guide: Preparing and Updating the Comprehensive Development Plan (CDP).⁶
- 5.3. Local Development Council (LDC) the body mandated by law to assist the Sanggunian concerned in setting the direction of economic and social development and coordinating development efforts within their respective territorial jurisdictions.⁷
- 5.4. Local Development Investment Program (LDIP) a basic document linking the local development plan to the budget for cities and municipalities. It contains a prioritized list of PPAs which are derived from the CDP matched with financing resources and to be implemented within a three to six-year period.⁸
- 5.5. Provincial Development and Physical Framework Plan (PDPFP) a document that identifies strategies and corresponding PPAs that serve as primary inputs to the provincial investment programming, budgeting, and implementation. The PDPFP also serves as a key vertical influence in linking provincial development objectives with local, regional, and national policies and priorities.⁹
- 5.6. Synchronized Local Planning and Budgeting Calendar (SLPBC) 2016 a calendar which specifies the schedule of planning, programming, and budgeting activities at the national and local levels.

6. Policy Content and Guidelines

Consistent with the provisions stipulated in the policies and guidelines issued by concerned NGAs in the preparation and formulation of local plans, all LGUs should have already formulated or updated their respective PDPFPs, PDIPs, and CDPs pursuant to the timelines prescribed in the SLPBC 2016.

To strengthen the harmonization of local development plans and ensure LGU compliance to the guidelines on CDP formulation, the provinces shall conduct an assessment of approved CDPs of their component cities and municipalities using the *BLGD CAT Form 1: CDP Assessment Checklist* and *BLGD CAT Form 1-A: Mainstreaming Sector/Thematic Concerns* (See Annex A).

6.1. Parameters for Assessment

Provinces shall assess the CDPs of component cities and municipalities in terms of form, content, and process.

- 6.1.1. Form To ensure that the submitted CDP is complete and determine whether the CDP complied with the templates and documentary requirements prescribed in the CDP formulation guidelines and policies.
- 6.1.2. **Process** To determine whether CDP formulation adopted the organizational/institutional processes (including information sharing, consultation, and consensus building) and content generation linkages prescribed in the CDP formulation guidelines and policies. This is to ensure that the CDP formulation process is consultative, participatory, and inclusive.
- 6.1.3. **Content** To assess the substance and logic of the CDP with emphasis on consistency, cohesiveness, responsiveness, and comprehensiveness. The analysis of LGU situation should have been clearly translated into the LGU vision and strategies. This also checks the alignment of the CDP with the PDPFP, PDIP, and CLUP.

6.2. Structure for Assessment

6.2.1. Prescribed Composition

Through the issuance of an Executive Order using the *BLGD CAT Form* 2 *Template* (See Annex B), the following shall be created and mobilized for the assessment of CDPs of component cities and municipalities:

- 6.2.1.1. CDP Technical Assessment Committee (CDP-TAC)
 - a. The CDP-TAC shall serve as a special functional committee under the Provincial Development Council (PDC).
 - b. The CDP-TAC shall be composed of the PPDC as chairperson; concerned Provincial Department Heads or their representatives, DILG Provincial Director or DILG Provincial CDP Focal Person, at least one (1) CSO/PO representative in the PDC, regional line agency representatives if available, as members; and other members that may be identified by the province.
- 6.2.1.2. Technical Assessment Committee Secretariat (TACS)

The TACS shall be comprised of staff from the Provincial Planning and Development Office (PPDO). Number of staff to be determined as appropriate by the CDP-TAC.

6.2.2. Prescribed Roles and Responsibilities

Roles and responsibilities of the Governor, C/MDC, CDP-TAC, and TACS in the conduct of the assessment process are hereby outlined as follows:

- 6.2.2.1. For the Governor's policy consideration as chair of the PDC:
 - a. Issuance of an Executive Order creating the CDP-TAC and TACS;
 - b. Issuance of a notice to the City/Municipal Mayors for the submission of CDPs; and,
 - Endorsement of results of the assessment of the CDP-TAC to the concerned City/Municipal Mayor.
- 6.2.2.2. In cases wherein the C/MDC needs clarification on the results of the assessment, the C/MPDC may consult/seek advice from the CDP-TAC.
- 6.2.2.3. CDP-TAC functions:
 - a. Assess the CDPs of all component cities and municipalities in the province;
 - The DILG Provincial CDP Focal Person shall spearhead the conduct of the technical assessment for the Form and Process components.
 - The PPDC, together with the Provincial Department Heads and regional line agency representatives, shall spearhead the conduct of the technical assessment for the *Content* component to include the alignment of the CDP with the PDPFP and PDIP.
 - Participate in technical activities for the assessment of the CDP;
 - c. Facilitate endorsement of assessment results to the Governor as chair of the PDC; and,
 - d. Provide advisory assistance to the C/MPDC as may be deemed necessary and in consideration of recommendations made as contained in the BLGD CAT Form 1: CDP Assessment Checklist and BLGD CAT Form 1-A: Mainstreaming Sector/Thematic Concerns.

6.2.2.4. TACS functions:

- Assist in the administrative preparation, coordination for the convening of the CDP-TAC, and documentation of assessment sessions;
- b. Consolidate results of the assessment and pertinent documents for endorsement to the PDC;
- c. Upload scanned copies and Excel files of the CDP Assessment Checklist in the Google Drive; and,
- d. Provide other administrative support to the CDP-TAC as may be necessary.

6.3. Mechanism of the Assessment Process

The following shall be undertaken in the assessment of CDPs of component cities and municipalities to: (i) ensure LGU compliance to the prescribed guidelines and processes relative to the formulation and preparation of CDPs and (ii) enhance city/municipal-province interface to strengthen alignment of local plans across levels of government:

- 6.3.1. The Provincial Governor shall cause the City/Municipal Mayor, as chair of the C/MDC, to submit the approved CDP of the component city/municipality to the PDC, through the PPDC as chair of the CDP-TAC, by issuing a Notice using *BLGD CAT Form 3: Notice for CDP Submission* (See Annex C).
- 6.3.2. The component city/municipality, through the C/MDC, shall submit three (3) hard copies and one (1) digital copy of the CDP and other pertinent documents identified in the *BLGD CAT Form 1: CDP Assessment Checklist* under *Component I: Form*.
- 6.3.3. The CDP-TAC, in plenary, shall conduct a desk assessment of the CDP using the *BLGD CAT Form 1: CDP Assessment Checklist* and *BLGD CAT Form 1-A: Mainstreaming Sector/Thematic Concerns*. The C/MPDC may be invited for an interview to clarify and/or validate the findings of the assessment.
- 6.3.4. The CDP-TAC shall endorse, for signature of the Provincial Governor, as chair of the PDC, the assessment results as contained in *BLGD CAT Form 1: CDP Assessment Checklist* and *BLGD CAT Form 1-A: Mainstreaming Sector/Thematic Concerns.*
- 6.3.5. The Provincial Governor shall provide the City/Municipal Mayor, copy furnished DILG PO, the results of the assessment process using the *BLGD CAT Form 4: Feedback Form* (See Annex D).

6.4. Period of Assessment (Timeline)

All CDPs that will undergo revision or updating are required to be subjected for assessment by the CDP-TAC. It is assumed that cities/municipalities will revise/update their CDPs immediately after an election and shall have it approved by March of the succeeding year prior to the budget call consistent with the SLPBC 2016.

In cases wherein the city/municipality revises/updates the CDP not within the timelines as prescribed by the SLPBC, concerned C/MDCs shall inform the PDC thru the CDP-TAC of the said revision/updating and submit the revised/updated CDPs for assessment.

The assessment activities shall thus be conducted within the following timelines:

6.5. Monitoring and Evaluation

The DILG Regional Office (DILG RO) and DILG Provincial Office (DILG PO) shall monitor and ensure that all CDPs of component cities and municipalities in the province are assessed.

- 6.5.1. The DILG PO, through the Provincial CDP Focal Person, shall:
 - 6.5.1.1. Ensure that the provinces upload scanned copies and Excel files of accomplished BLGD CAT Form 1: CDP Assessment Checklist and BLGD CAT Form 1-A: Mainstreaming Sector/Thematic Concerns to the Google Drive link: https://tinyurl.com/ycbe6e8a. The Google Drive link can be accessed by the DILG Provincial/Regional/Central Offices.
 - 6.5.1.2. Submit the BLGD CAT Form 5: Provincial Monitoring Report of CDP Assessment (See Annex E) to the DILG Bureau of Local Government Development (DILG BLGD), copy furnished DILG RO, every 30th of June of the ensuing year after an election (e.g. 30 June 2020, 30 June 2023, 30 June 2026) for the subsequent years.
- 6.5.2. The DILG RO, through the Regional CDP Focal Person, shall:
 - 6.5.2.1. Ensure that all provinces within the region have uploaded scanned copies and Excel files of accomplished BLGD CAT Form 1: CDP Assessment Checklist and BLGD CAT Form 1-A: Mainstreaming Sector/Thematic Concerns to the Google Drive.
 - 6.5.2.2. Monitor and ensure submission of *BLGD CAT Form 5: Provincial Monitoring Report of CDP Assessment* to the DILG BLGD.

6.6. Baselining for FY 2018: Informing the Updating/Revision of the CDP in FY 2019

To set a baseline on: (i) adherence of component cities/municipalities to prescribed guidelines for CDP formulation and (ii) extent of alignment of CDPs/LDIPs of component cities and municipalities with that of provinces, all

provinces shall conduct a CDP assessment in 2018 with schedule of assessment and report submissions as follows:

While this policy prescribes the process by which the CDP Assessment Tool can be utilized by the province to assess approved CDPs, the assessment tool may also be used as a basis for Sangguniang Panlungsod/Bayan approval of the CDP.

The nationwide CDP assessment for FY 2018 shall inform the updating/revision of the CDPs in FY 2019. The cyclical nature of the assessment, to be conducted every three (3) years, allows for the results to be used as inputs to the medium-term updating/revision of CDPs in subsequent years and annual updating of the LDIP. The CDP Assessment Tool has identified parameters for evaluating critical elements of the CDP and the Sangguniang Panlungsod/Bayan are well advised to adopt the tool for evaluation of CDPs endorsed by the LDCs for approval. This shall ensure that cities/municipalities are able to comply against the standards/parameters by which they shall be assessed by the province and to enhance complementation and alignment with provincial strategies and priorities.

CREATING AND MOBILIZING THE COMPREHENSIVE DEVELOPMENT PLAN TECHNICAL ASSESSMENT COMMITTEE (CDP-TAC) AND TECHNICAL ASSESSMENT COMMITTEE SECRETARIAT (TACS) FOR THE ASSESSMENT OF THE CDPs OF COMPONENT CITIES AND MUNICIPALITIES, PROVIDING FOR ITS COMPOSITION, ROLES AND RESPONSIBILITIES, AND FOR OTHER PURPOSES

WHEREAS, Republic Act (RA) No. 7160 or the Local Government Code of 1991 (LGC) mandates all cities and municipalities to prepare a Comprehensive Development Plan (CDP) that outlines the key goals and objectives, challenges, and concerns facing local government units (LGUs) and identifies a set of programs, projects, and policies to attain its vision and mission towards a sustainable and holistic socio-economic development;

WHEREAS, RA 7160 further provides that the Local Development Council (LDC) is the body mandated by the LGC to prepare the multi-sectoral development plan of an LGU thus it is critical to ensure that the LDC as well as its functional and sectoral committees, as providers of technical support and assistance are constituted and activated including the technical working group for that purpose;

WHEREAS, DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 2016 (JMC No. 2016-1) entitled Updated Guidelines on the Harmonization of Local Planning, Investment Programming, Resource Mobilization, Budgeting, Expenditure Management, and Performance Monitoring and Coordination in Fiscal Oversight, issued on 18 November 2016, provides that the shared oversight function of the province over its component cities and municipalities shall be strengthened through the development and implementation of tools to ensure compliance of component LGUs to established policies and guidelines on public financial management (PFM);

WHEREAS, DILG Memorandum Circular 2018-____ Comprehensive Development Plan Assessment for Component Cities and Municipalities provides that the Provincial Development Council (PDC) thru a Special Functional Committee created for the purpose, shall assess the CDPs of its component cities and municipalities for compliance to established guidelines on the formulation of the CDP; its alignment with the Provincial Development and Physical Framework Plan (PDPFP), Provincial Development Investment Program (PDIP), Comprehensive Land Use Plan (CLUP); and, to national development thrusts and strategic directions as part of the provinces' shared oversight function with concerned national government agencies,

The TACS shall assist in the administrative preparation, coordination, and documentation of all assessment activities; and in the consolidation of assessment results and pertinent documents for endorsement to the PDC. The TACS shall also provide other administrative support to the CDP-TAC as may be necessary.

SECTION 3. RELATIONSHIP WITH THE PROVINCIAL DEVELOPMENT COUNCIL

The CDP-TAC shall act as a special functional committee of the PDC tasked to assess the CDPs of all component cities and municipalities of the province. All its actions shall be subject to the assessment and approval of the PDC through its Chairman.

SECTION 4. SUPPORT REQUIREMENTS

The CDP-TAC may call upon the assistance of relevant units and/or LGU personnel, through the respective department heads, in the implementation of various activities relative to the assessment of the CDPs.

Moreover, everyone is enjoined to participate in the various activities of the CDP-TAC as deemed necessary.

SECTION 5. EFFECTIVITY

The CDP-TAC including the TACS shall exercise their duties and functions effective immediately.
