ENDORSING THE NOMINATION OF THE MUNICIPALITY OF CAIBIRAN, BILIRAN FOR THE CONSISTENT REGIONAL OUTSTANDING WINNER IN NUTRITION (CROWN) AWARD

WHEREAS, the Municipality of Caibiran, Biliran has consistently been awarded as the regional outstanding winner in nutrition;

WHEREAS, the outstanding municipality in the region was validated by the regional evaluation team using a management tool to: a) assess progress of plan implementation; b) identify strengths and weaknesses in implementing the local nutrition program; c) institute appropriate corrective measures; and d) facilitate achievement of the plan's objectives;

WHEREAS, to be conferred with Green Banner Award the local government unit must attain a minimum and final average rating, as: 1) Outstanding Municipality in the Province of 85%, and 2) Outstanding Municipality in the Region of 88%;

WHEREAS, the outstanding municipality in the region should come from among the first ranking municipalities in the provinces of the region;

WHEREAS, the Municipality of Caibiran established various collaborations through linkages of many public and private organizations, enacted resolutions and ordinances, strengthened nutrition specific and nutrition sensitive programs to reach its goal of reducing the prevalence of malnutrition and promotion of better health among all Caibiranons;

WHEREAS, the collective and sustained efforts of the different stakeholders a package of nutrition intervention, the municipality is successful in reducing the prevalence of underweight among preschool children from 9.9% in 2015 to 5.2% in 2017;

WHEREAS, in the year 2015, 2016, and 2017 the Municipality of Caibiran was adjudged Provincial Outstanding Municipality and subsequently the Outstanding Municipality in the Region;

WHEREAS, the CROWN award is accorded to local nutrition committees or the local government units who has consistently been pursuing for the desire in the quest for nutrition improvement through its consistent efforts as outstanding municipality in the region in the last three consecutive years;
