**RESOLUTION COMMENDING SCHOOLS DIVISIONS WITH EXCELLENT  
RESULTS IN IMPLEMENTING THE SCHOOL-BASED FEEDING PROGRAM FOR  
THREE SCHOOL YEARS (SY 2016-2017 TO SY 2018-2019)**

**WHEREAS**, the Department of Education through DepED Order 51, s. 2016 and DepED Order 39, s. 2017 mandates the conduct of the School Based Feeding Program (SBFP) for elementary students from school years covering 2016 to 2020 with the objective of improving the nutritional status of the children who are wasted and severely wasted and increasing school attendance of the beneficiaries;

**WHEREAS**, the SBFP in the Cordillera region was implemented in all provinces through their respective schools divisions;

**WHEREAS**, the SBFP targets improvement of nutritional status of the malnourished school children by 70% at the end of the 120 feeding days and achieve 85% of classroom attendance;

**WHEREAS**, there were Schools Divisions implementing the SBFP who were able to exceed the target and sustain a high rating of 90% improvement of the nutritional status of beneficiaries and 90% classroom attendance for the past three school years from SY 2016-2017 to SY 2018-2019;

**WHEREAS**, based on the SBFP reports, validated by DepED-CAR School Health Unit, the Divisions of Tabuk City and Mountain Province met the 90% criteria for the nutritional status improvement and classroom attendance;

**WHEREAS**, providing recognition to the said divisions would inspire and motivate more schools to improve the implementation of their SBFP and sustain their performance;

**NOW THEREFORE ON MOTION DULY SECONDED, BE IT RESOLVED, AS IT IS  
HEREBY RESOLVED**, that the RNC gives commendation to the Schools Divisions with excellent results in implementing the school-based feeding program for three school years (SY 2016-2017 to SY 2018-2019);
