## ENJOINING REGIONAL LINE AGENCIES TO GIVE PRIORITY FOCUS ON ABRA IN THE IMPLEMENTATION OF NUTRITION AND NUTRITION RELATED INTERVENTIONS

WHEREAS, Results of the 2019 Operation Timbang conducted by local government units and 2019 baseline nutritional assessment of school age (Elementary and High school) children conducted by the Department of Education showed that among the provinces of CAR, Abra has the highest malnutrition prevalence in most of the nutrition indicators indicating the malnutrition problem is greatest;

WHEREAS, results of previous years showed a similar trend with Abra having higher malnutrition rates in the region compared to other LGUs;

WHEREAS, regional line agencies provide and implement nutrition and nutrition related programs in the different LGUs of the region;

WHEREAS, there is a need to update the Regional Plan of Action on Nutrition 2020-2022 based on updated programs/projects/activities of agencies for nutrition;

NOW THEREFORE, ON MOTION DULY SECONDED, BE IT RESOLVED AS IT IS HEREBY RESOLVED, that agencies update their plans/programs and activities in the RPAN Implementation Plan and Results Framework and Investment Plan giving priority to Abra as a target area for implementation;

**RESOLVED FURTHER,** that the RNC conduct an advocacy meeting with the expanded provincial health board of Abra at a date to discuss the nutrition situation and call for stronger support for nutrition among key stakeholders;

**RESOLVE FURTHER**, that draft a resolution for endorsement to RSDC enjoining LGUs of Abra to strengthen implementation of nutrition programs to improve the nutrition situation in their respective LGUs;

RESOLVED FINALLY, that the RNC holds a special meeting on April 3, 2020 with the following agenda:

- a) Preparation for the advocacy meeting with the expanded Provincial Health Board of Abra;
- b) Discussion of draft resolution for endorsement to RSDC enjoining Abra LCEs to strengthen nutrition program implementation;

c) Presentation of agency updated programs/projects/activities for the RPAN highlighting commitments for Abra.
