**APPROVING THE RNC-CAR TECHNICAL ASSISTANCE ACTIVITIES FOR THE
PROVINCE OF APAYAO**

WHEREAS, results of the 2020 Operation Timbang conducted by local government units, showed that Apayao is among the top three provinces in CAR with high malnutrition prevalence in all nutrition indicators and results of the SY 2019-2020 Nutrition Assessment of elementary school children conducted by the Department of Education showed that Apayao has higher prevalence among the provinces in CAR.

WHEREAS, Apayao, one of the focus provinces of the Philippine Plan of Action for Nutrition (PPAN) due to its high malnutrition, high teenage pregnancy and poverty incidence, is one of the target provinces for the dietary supplementation program dubbed as "Tutok Kainan" program of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases and Inter-Agency Task Force Zero Hunger.

WHEREAS, the dietary supplementation program will cover 6-23 months children who are severely wasted/wasted and severely stunted/stunted in all the municipalities of Apayao except for the municipality of Luna.

WHEREAS, the RNC recognizes the need to supplement efforts of the national government for Apayao by helping strengthen nutrition program implementation in municipalities of the province towards the reduction of malnutrition rates.

**NOW THEREFORE, ON MOTION DULY SECONDED, BE IT RESOLVED AS IT IS
HEREBY RESOLVED**, that the Regional Nutrition Committee approves the proposed technical assistance activities for the province of Apayao as presented.


RESOLVED FINALLY that NNC provide updates on the implementation of the technical assistance in the next RNC Meeting.
