**CONFIRMING THE AWARDEES FOR THE 2022 REGIONAL NUTRITION  
AWARDING CEREMONY (RNAC)**

**WHEREAS**, the Philippine Plan of Action for Nutrition (PPAN) 2017-2022, an integral part of the Philippine Development Plan, is the systematic integration of efforts of government and private agencies and institutions to address the country's malnutrition problem;

**WHEREAS**, progress of the implementation of PPAN at various levels is done using various monitoring activities such as the Monitoring and Evaluation of Local Level Plan Implementation Protocol (MELLPI Pro);

**WHEREAS**, MELLPI measures program efficiency in relation to program outreach, budget allocation and expenditure including policies issued; it also measures change in nutritional status among preschool and school children; likewise, performance of the barangay nutrition scholar in the management of nutrition program and monitoring and referral of the malnourished children at the barangay level is being assessed;

**WHEREAS**, the Regional Nutrition Evaluation Team (RNET) was organized to appraise the efforts of the barangays, municipalities, cities and provinces in the implementation of the programs, projects and activities (PPAs) based on the formulated Local Nutrition Action Plans with the integration of the nutrition and related interventions amid the COVID-19 situation;

**WHEREAS**, the 2022 RNAC seek to recognize not only the continuous nutrition program management implementation of the LGUs and the excellent performance of the local nutrition focal points but will commend developmental partners and stakeholders who showed impressive efforts in COVID-19 response;

**WHEREAS**, the RNET agreed to recognize LGUs and individuals with the following commendations (*See Annex A*):

- a. LGUs with Above 80% Coverage in the 2022 Operation Timbang Plus (OPT+);
- b. LGUs with Low Level of Stunting Prevalence Rate <10 WHO Cut-off from 2022;
- c. Commendable Mobilization Advocacy of the Provincial Nutrition Office on Integrating Nutrition Programs, Projects, and Activities in the 2021 Annual Investment Program;
- d. LGUs for Active Participation in the 2021 Regional and Provincial Monitoring and Evaluation on Local Level Plan Implementation;

- e. Regional NAO, Regional NPC, Regional BNS Federations, RNTWG, RNET, Caraga MOVERS, Special Citations to Retirees/RNTWG as Nutrition Advocates, Special Citations - Post Humous Recognition, P/COBNS, Contender for Regional NAO


