RNC-NCR RESOLUTION NO. 01 Series of 2022

RESOLUTION ADOPTING THE SCALING UP NUTRITION (SUN) 3.0 STRATEGY AND ORGANIZATION OF REGIONAL SUN MOVEMENT NEWORKS IN THE NATIONAL CAPITAL REGION (NCR)

WHEREAS, the Scaling Up Nutrition (SUN) Movement is a renewed effort to eliminate all forms of malnutrition, based on the principle that everyone has a right to food and good nutrition;

WHEREAS, the SUN is a global movement which unites governments, civil society, donors, businesses, the United Nations, academe, researchers, and citizens in a collective effort to improve nutrition;

WHEREAS, the SUN Movement encourages multisectoral and multi-stakeholder working together to bring about an end to malnutrition;

WHEREAS, the SUN Movement envisions a world free from malnutrition in all its forms by 2030, led by countries and governments, supported by organizations and individuals, through collective action ensures every child, adolescent, mother and family can realize their right to food and nutrition, reach their full potential and shape sustainable and prosperous societies;

WHEREAS, the NNC Governing Board through its Resolution No.2, Series of 2014 approved the Philippine registration in the SUN Movement to gain support from other SUN member countries and international development partners, and the United Nations agencies in improving the nutrition situation of the country and in harmonizing existing strategies to ensure effective implementation in order to achieve nutrition targets;

WHEREAS, the SUN Strategy 2021–2025 or SUN 3.0 emphasizes impact on nutrition at the country level and country leadership in addressing all forms of malnutrition;

WHEREAS, SUN 3.0 aims to contribute towards achieving the goals of the 2030 Agenda for Sustainable Development and the Global Targets 2025 to improve maternal, infant and young child nutrition;

WHEREAS, the SUN 3.0 empowers the countries to lead and take ownership on investible nutrition-specific and nutrition-sensitive priorities backed by committed political and institutional systems;

RESOLUTION ADOPTING THE SCALING UP NUTRITION (SUN) 3.0 STRATEGY AND ORGANIZATION OF REGIONAL SUN MOVEMENT NEWORKS IN THE NATIONAL CAPITAL REGION (NCR)

WHEREAS, the SUN 3.0 will be more country-led and country-driven by achieving four strategic objectives (SOs) to accelerate results to eliminate all forms of malnutrition by 2030:

- (1) strengthen and sustain strong policy and advocacy to position nutrition outcomes;
- (2) develop and align shared country priorities for action;

- (3) build and strengthen country capacity with technical assistance and knowledge management; and
- (4) ensure SUN governance promotes country leadership and government responsibilities, aligns resources and strengthens mutual accountabilities;

WHEREAS, the national launch of the SUN 3.0 held on June 4, 2021 calls for a collective action at the regional level through the organization of the regional SUN Movement networks that can work with the government in improving the nutrition situation in the region and in the country;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled, to Adopt the Scaling Up Nutrition (SUN) 3.0 Strategy and Organize the Regional SUN Movement Networks in the National Capital Region;

RESOLVED FURTHER, for the NNC-NCR to lead in convening and organizing regional networks of business, civil society, and academe:

- SUN Business Network will gather support from businesses and private sectors to invest in initiatives and programs that will reduce malnutrition;
- SUN Civil Society Network will work closely with communities to ensure that efforts to scale up nutrition are equitable, and serve as strong nutrition advocates;
- c. SUN Academe Network will elevate the role of academe in driving the evidence base; strengthen research capacity; prioritize implementation of science and research; and leverage their academic voice to advocate for and position nutrition.

RESOLVED FURTHER, for the NNC-NCR Regional Office being the RNC Secretariat to:

- 1. report the status of organization of regional SUN networks to the RNC and their accomplishments; and
- 2. review the effectiveness of implementation of this resolution after three (3) years of its implementation

RESOLVED FURTHER, that the NNC-NCR Regional Office being the Secretariat of the RNC to furnish the NNC Central Office, all regional members of the RNC and all local government units in the region a copy of this resolution.
