RNC-CAR Resolution No. 6 Series of 2016

RECOGNIZING THE BARANGAYS, CITIES, MUNICIPALITIES AND PROVINCES THAT HAVE SIGNIFICANTLY CONTRIBUTED TO THE ACHIEVEMENT OF THE MILLENNIUM DEVELOPMENT GOAL TARGETS ON NUTRITION

WHEREAS, the Cordillera Administrative Region (CAR) has reduced the prevalence of undernutrition from 5.38% in 2010 to 4.45% in 2015 based on the annual Operation Timbang Plus results, and had the second lowest prevalence of underweight and severely underweight children among regions in the country based on the National Nutrition Survey conducted by the Food and Nutrition Research Institute (FNRI) in 2013;

WHEREAS, the good performance of some local government units (LGUs) contributed to the positive regional performance in reducing the prevalence of malnutrition and to the attainment of the Millennium Development Goals (MDG), specifically the targets on nutrition under MDG 1;

WHEREAS, the Regional Nutrition Committee (RNC) recognizes high-performing LGUs in the implementation of nutrition programs, which are determined through the yearly conduct of the Monitoring and Evaluation of Local level Plan Implementation (MELLPI);

WHEREAS, the RNC has included in the 2016 Regional Nutrition Awarding Ceremony municipal LGUs that have recorded consistent decreases in malnutrition rates in the last three years (2013-2015);

WHEREAS, LGUs that have significantly contributed to the improvement of the nutritional status of pre-school children towards attaining MDG targets deserve to be recognized and awarded; this would also provide encouragement to other LGUs to perform well;

NOW THEREFORE, on motion duly seconded, BE IT:

RESOLVED, as it is hereby resolved, that the Regional Nutrition Committee recognizes the barangays, cities, municipalities and provinces that have significantly contributed to the achievement of the Millennium Development Goal targets on nutrition, as follows:

- Provinces, cities and municipalities that have shown consistent decreases in malnutrition rates in the last three years (2013, 2014 and 2015);
- b) Provinces, cities and municipalities that have attained and sustained prevalence of underweight and severely underweight below 1% in the last three years (2013, 2014 and 2015);
- c) Barangays that have attained zero malnutrition in the last three years (2013, 2014 and 2015);

RESOLVED FURTHER, that the NNC shall facilitate the identification of these barangays, cities, municipalities and provinces and their recognition during the 2016 Regional Nutrition Awarding Ceremony;
