RNC-CAR Resolution No. 7 Series of 2016

ADOPTING THE LGU MOBILIZATION STRATEGY FOR IMPROVED NUTRITION IMPLEMENTATION

WHEREAS, findings of the Monitoring and Evaluation of Local Level Plan Implementation (MELLPI) and results of the Operation Timbang Plus indicate that the performance of different local government units (LGUs) vary in terms of implementation of nutrition and related interventions;

WHEREAS, there is a need to strengthen technical assistance to low performing LGUs to help improve their performance and make a difference in the improvement of the nutritional status of children and the general population;

WHEREAS, there is also a need to strengthen assistance to high performing LGUs especially those aiming for nutrition awards to boost their competitiveness and increase the number of nutrition awardees in the region;

WHEREAS, the proposed LGU mobilization strategy aims to enhance LGU performance through a mix of mechanisms to capacitate LGUs in a manner that is efficient, equitable sustainable, and empowering;

NOW THEREFORE, on motion duly seconded, BE IT:

RESOLVED, as it is hereby resolved, that the RNC adopt the LGU Mobilization Strategy for improved nutrition implementation, as follows:

- Formation of a Nutrition Regional Core Team to be convened by the NNC-CAR with the following functions:
 - Provide coaching and mentoring to low performing LGUs along planning, investment programming and budgeting, implementation, and monitoring and evaluation of nutrition programs;
 - b) Provide assistance to awardees and potential awardees especially on report preparation and documentation; and
 - c) Plan and implement other nutrition and related activities with the aim of improving LGU performance on nutrition;
- Selection of low performing municipalities for possible assistance will be based on the following criteria:
 - a) High percentage of wasting and stunting among children under five years old;
 - b) Support of local chief executives;
 - c) Presence of an able Nutrition Action Officer; and
 - d) Extent of coverage of the Pantawid Pamilyang Pilipino Program (4Ps);
- Prioritization of high performing LGUs, especially those vying for Consistent Regional Outstanding Winner in Nutrition (CROWN), CROWN maintenance, and Nutrition Honor Award (NHA); and
- Provision of assistance by high performing LGUs to other LGUs on nutrition program planning, investment programming and budgeting, implementation, and monitoring and evaluation;

RESOLVED FURTHER, that this LGU Mobilization Strategy form part of the RNC Strategic Plan for 2017 and onwards, to be monitored and evaluated by the RNC.
