RNC-CAR Resolution No. 2, series of 2018

RESOLUTION APPROVING THE ANNUAL RECOGNITION OF HIGH PERFORMING LGUs BASED ON MELLPI SCORES, LGUs WITH CONTINUOUS DECREASE IN STUNTING PREVALENCE AMONG 0-59 MONTHS CHILDREN IN THE LAST THREE YEARS, AND LGUs WITH STUNTING PREVALENCE OF LESS THAN TEN PERCENT

WHEREAS, the Monitoring of Local Level Plan Implementation (MELLPI) is a tool that monitors and rates the quality of nutrition program implementation of Local Government Units (LGUs) and is also used in identifying awardees for Green Banner, Consistent Regional Outstanding Winner on Nutrition (CROWN) and Nutrition Honor Award (NHA);

WHEREAS, there is no regional system of recognizing high performing LGUs based on MELLPI scores outside the Green Banner, CROWN and NHA;

WHEREAS, there are some LGUs that show high quality nutrition program implementation with high MELLPI scores but are not recognized under the current recognition and awards system;

WHEREAS, recognition of LGUs with high performance ratings can inspire and motivate more LGUs to improve their nutrition program implementation and sustain their performance;

WHEREAS, decrease in the stunting prevalence is a major indicator of success of the Philippine Plan of Action on Nutrition and local plans of action on nutrition;

WHEREAS, about 4 out of 10 of pre-school children (0-59 months) in CAR are stunted based on the 2015 National Nutrition Survey of FNRI DOST with CAR having a higher prevalence than the national;

NOW THEREFORE RESOLVED, AS IT IS HEREBY RESOLVED, that the Regional Nutrition Committee approves the annual recognition of high performing LGUs based on MELLPI scores, LGUs with continuous decrease in stunting prevalence among 0-59 months children in the last three years, and LGUs with stunting prevalence of less than ten percent;
