OPERATIONALIZATION OF THE REGIONAL BANTAY ASIN TASK FORCE (RBATF) IN CARAGA REGION

WHEREAS, RA 8172 otherwise known as "An Act Promoting Salt Iodization Nationwide and for Related Purposes", or commonly called "ASIN Law" is a major step to end Iodine Deficiency Disorders (IDD) through the cost-effective preventive measure of salt iodization;

WHEREAS, effective implementation of the law requires a strong mechanism for monitoring to ensure that only adequately-iodized salt is available for human and animal consumption;

WHEREAS, such mechanism can involve the organization of a group of monitors of adequately-iodized salt in the region;

- 3. Monitoring and evaluating program implementation through meetings for update on program implementation and to discuss and address implementation problems and issues, visit warehouse of salt distributors and monitoring salt in ports; and
- 4. Recommending to the Regional Nutrition Committee, National Salt Iodization Program-related regional policies;
