RNC-NCR RESOLUTION NO. 03

**RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS (LGUS)
TO PROVIDE FUNCTIONAL HEIGHTBOARDS TO ALL BARANGAYS IN SUPPORT
OF THE OPERATION TIMBANG Plus (OPT +)**

WHEREAS, the Governing Board of the National Nutrition Council in its Resolution No.2, Series 2008 adopted the World Health Organization-Child Growth Standards for use for 0-5 years old in the Philippines;

WHEREAS, based on the Department of Health Administrative Order (DOH-AO) No 2010-0015 entitled "Revised Policy on Child Growth Standards", growth and development of children 0-5 years old shall be assessed by measuring their weights and heights regularly;

WHEREAS, based on the same AO, LGUs shall ensure availability of weighing scales, microtoise, infantometers, height boards, ECCD cards, WHO-CGS tables and charts and other necessary supplies to be used for the assessment and recording of nutritional status;

WHEREAS, inspite of the national adoption and availability of guidelines, there are still a number of areas in the region who are not following the Guidelines on the Fabrication, Verification and Maintenance of Wooden Height Boards (Attachment 1) in fabricating their heightboards;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled, to enjoin all LGUs to provide functional height boards to all barangays, and ensure compliance to the guidelines on Operation Timbang Plus and Fabrication Verification and Maintenance of Wooden Height Boards;
