RESOLUTION ADOPTING THE REVISED GUIDELINES
ON THE SHEPHERDING PROJECT

WHEREAS, one of the Regional Nutrition Committee's (RNC) mandate is to issue policies, guidelines and recommendations that will support the nutrition program in the region;

WHEREAS, during the RNC meeting held February 17, 2012, RNC Resolution No.1 Series 2013 entitled "Adopting the Guidelines on the Shepherding of Local Nutrition Committees for Implementation in the National Capital Region" was approved;

WHEREAS, prior to the Shepherding Project implementation, preliminary activities conducted were the following: conduct of an Orientation on Nutrition Program Management (NPM) among the members of the Regional Nutrition Management Group (RNMG) to prepare them for their tasks as "shepherds"; dissemination of the RNC Resolution to all member agencies of the RNC and to the Local Chief Executives, Nutrition Action Officers (NAOs), and City/District Nutrition Program Coordinators (C/DNPCs) of the 16 cities and one municipality in NCR and presentation of the shepherding concept during meetings of NAOs and C/DNPCs;

WHEREAS, in 2012, RNC through the Regional Nutrition Management Group conducted shepherding to priority LNCs;

WHEREAS, on September 17, 2015, the RNC Resolution No. 1, S2012 "Adopting the Shepherding Guidelines of Local Nutrition Committees" was reviewed by Technical Working Group led by the National Nutrition Council – National Capital Region and representatives from the Department of the Interior and Local Government-NCR, Department of Social Welfare and Development-NCR, Department of Agriculture-IV-A, Rural Improvement Clubs of the Philippines, Metropolitan Manila Development Authority, Department of Health - NCRO and Grace Family Helper Project;

WHEREAS, the revised shepherding guidelines was presented during the meeting with RNC, RNMG and Association of Nutrition Action Officers of NCR in 2015 for further inputs;
