RNC-NCR RESOLUTION NO. 02 Series of 2016

RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS IN THE NATIONAL CAPITAL REGION TO MAINSTREAM NUTRITION IN ALL HEALTH SERVICE DELIVERY POINTS

WHEREAS, the Department of Health's Universal Health Care High Impact Five (UHC-Hi5) is a strategy which aims to produce the greatest improvements in health outcomes and the highest impact on vulnerable population;

WHEREAS, the objectives of the High Impact Five (Hi5) Strategies of the Department of Health are to: a) reduce maternal mortality, under-five mortality, infant mortality rate; b) halt HIV/AIDS and c) strengthen service delivery network;

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) is the country's response to malnutrition and provides a framework in improving the nutritional status of Filipinos;

WHEREAS, the Hi5 and PPAN strategies can contribute to the improvement of nutritional wellbeing of Filipino families;

WHEREAS, the Local Government Units are the key implementers of the PPAN and health services at the local levels;

WHEREAS, integrating nutrition in all health service delivery points can contribute to the improvement of nutrition and health well-being of the population particularly the vulnerable ones;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled, enjoins all LGUs in the National Capital Region to mainstream nutrition in all health service delivery points;

RESOLVED FURTHER, that the NNC-NCR Regional Office being the Secretariat of the RNC shall furnish the NNC Central Office, all regional members of the Committee and all local government units in the region a copy of this resolution.
