**RESOLUTION ADOPTING THE UPDATED MEDIUM-TERM PHILIPPINE  
PLAN OF ACTION FOR NUTRITION (MTPPAN 2008-2010)**

**WHEREAS**, the Philippines is committed to achieve the Millennium Development Goals (MDGs) particularly on goal number 1, the eradication of extreme poverty and hunger by reducing to half the proportion of households below the minimum dietary energy consumption and the proportion of underweight 0-5 years old children;

**WHEREAS**, based on the 2008 results of the National Nutrition Survey conducted by the Food and Nutrition Research Institute (FNRI), infants, children, pregnant and lactating women are affected with malnutrition problems;

**WHEREAS**, the Medium-Term Philippine Plan of Action for Nutrition (MTPPAN) is the government's blueprint for action to address the country's nutrition problems as incorporated in the Medium-Term Philippine Development Plan (MTPDP) 2004-2010 under the chapter on "Responding to the Basic Needs of the Poor";


**WHEREAS**, consistent with the MTPDP updating, a mid-term assessment of the MTPPAN 2005-2010 was done which identified adjustments to be done and priority actions to pursue;

**WHEREAS**, the MTPPAN 2008-2010 targets will be focused on reducing the prevalence of underweight 0-5 and 6-10 years old children, vitamin A deficiency, anemia and iodine deficiency disorders; reducing the proportion of households with inadequate caloric intake; and contribute to reduced levels of indicators of risk factors associated with non-communicable diseases;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED**, in consideration of the above premises, we the Regional Nutrition Committee do hereby adopt the Updated MTPPAN 2008-2010;


