**RESOLUTION ADOPTING THE UPDATED REGIONAL NUTRITION
COMMITTEE STRATEGIC PLAN 2015-2016**

WHEREAS, in 2012, the Regional Nutrition Committee (RNC) of NCR formulated its Strategic Plan for 2012-2016 through a workshop and series of meetings;

WHEREAS, from 2012 to 2014, various strategic actions and activities indicated in the approved RNCSP 2012-2016 were undertaken by the RNC member agencies to achieve the targets set therein;

WHEREAS, because of the results of the 2013 National Nutrition Survey (NNS) and the updated Philippine Plan of Action for Nutrition (PPAN) 2014-2016, there is a need to revisit the RNCSP 2012-2016 to ensure that the strategies and activities contained therein are aligned with the updated PPAN 2014-2016 and responsive to the current nutrition situation in the region;

WHEREAS, NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled to approve the Regional Nutrition Committee Strategic Plan for 2015-2016;

RESOLVED FURTHER, to request the Department of the Interior and Local Government-NCR to enjoin all the Local Government Units in NCR to adopt the Updated RNC Strategic Plan 2015-2016;

RESOLVED LASTLY, that the NNC-NCR Regional Office being the Secretariat of the RNC to furnish the NNC Central Office, all regional members of the RNC and all local government units in the region a copy of this resolution.
