RNC-NCR RESOLUTION NO. 03

**RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS (LGUs) IN THE
NATIONAL CAPITAL REGION TO ADOPT THE GUIDELINES ON LOCAL
NUTRITION PLANNING IN THE FORMULATION OF THEIR 3-YEAR LOCAL
NUTRITION ACTION PLAN (LNAP)**

WHEREAS, the Governing Board of the National Nutrition Council in its Resolution No.3, Series 2014 approved and adopted the Guidelines on Local Nutrition Planning;

WHEREAS, based on the Operation Timbang results conducted annually in the 17 LGUs of NCR, the double burden of malnutrition exists due to the presence of both under and overnutrition among children;

WHEREAS, with the existing problem of double burden of malnutrition in the region, there is a need for strategic and purposive action to address these nutritional problems; and with devolution, LGUs play a pivotal role in reversing the trend in both under and overnutrition and in ensuring good nutrition among the population;

WHEREAS, the local nutrition action plan (LNAP) is a three year – plan containing objectives and nutrition interventions that will address the malnutrition problem at the city, municipal and barangay level;

WHEREAS, the formulation of LNAP and its integration to the local development plan and annual investment plan will help ensure that nutrition action at the local level is strategic and purposive;

WHEREAS, the Local Nutrition Committee (LNC) is responsible for Nutrition Program Management (NPM) and is the mechanism for planning, implementing, monitoring, evaluating, and coordinating the city/municipal plan of action for nutrition;

WHEREAS, the NNC Governing Board had approved and adopted the Guidelines on Local Nutrition Planning as a guide of the Local Nutrition Committee in formulating a nutrition action plan that would address the existing nutritional problems in their locality; and define processes and tools that will facilitate the formulation of a provincial, city and municipal nutrition action plan that is harmonized with national and local development planning;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled, to enjoin all LGUs in the National Capital Region to adopt the Guidelines on Local Nutrition Planning in the formulation of their 3-year LNAP;
