**RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS (LGUs)
IN THE NATIONAL CAPITAL REGION TO ADOPT
THE LOCAL NUTRITION COMMITTEE FUNCTIONALITY CHECKLIST**

WHEREAS, malnutrition is a multifaceted problem requiring a multi-sectoral mix of interventions towards its sustained reduction;

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) serves as the framework to guide stakeholders on how to contribute to improved nutrition of the country;

WHEREAS, the Local Nutrition Committee (LNC) is responsible for Nutrition Program Management (NPM) and is the mechanism for planning, implementing, monitoring, evaluating, and coordinating the city/municipal plan of action for nutrition;

WHEREAS, the LNC is composed of the Mayor (as chairperson), City/Municipal Nutrition Action Officer (as focal person), City/Municipal Nutrition Program Coordinator, City/Municipal Planning and Development Officer, City/Municipal Health Officer, City/Municipal Agriculture Officer, City/Municipal Social Welfare and Development Officer, Department of Education Superintendent, Local Government Operations Officer, chapter head of nutrition and related organizations, local authorized Non-Government Organizations and others as may be identified by the committee;

WHEREAS, it is critical that all LGUs have functional LNC to efficiently and effectively implement and manage the nutrition program;

WHEREAS, the National Nutrition Council developed a list of criteria to determine the functionality of LNCs;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled, enjoins all LGUs in the National Capital Region to adopt the LNC Functionality Checklist;

RESOLVED FURTHER, that the NNC-NCR Regional Office being the Secretariat of the RNC shall furnish the NNC Central Office, all regional members of the RNC and all local government units in the region a copy of this resolution.
