**RESOLUTION ADOPTING THE GUIDELINES ON THE SHEPHERDING OF
LOCAL NUTRITION COMMITTEES FOR IMPLEMENTATION IN
THE NATIONAL CAPITAL REGION**

- WHEREAS,** the Regional Nutrition Committee (RNC), an inter-sectoral body composed of Regional Directors or regional heads of national government agencies and other bureaus or agencies and representatives from the private sector, is responsible for coordinating and monitoring the implementation of agency nutrition programs in support of the Philippine Plan of Action for Nutrition (PPAN) in the region;
- WHEREAS,** part of the RNC's mandate is to issue policies, guidelines and or recommendations that will support the nutrition program in the region;
- WHEREAS,** the technical arm of the RNC is called the Regional Management Group (RMG), which is represented by the middle managers/representatives of member agencies of the RNC;
- WHEREAS,** the RNC sees the need for closer monitoring and mentoring of local nutrition committees based on the results of the annual Monitoring and Evaluation of Local Level Plan Implementation (MELLPI) and Program Implementation Review (PIR) to improve their nutrition program management;
- WHEREAS,** the Shepherding of Local Nutrition Committees (LNCs) is a strategy that will be adopted by the RNC which will allow frequent monitoring visits to local government units by the members of the RMG for in-depth interaction with and mentoring of LNC members to assist them in improving their nutrition program management resulting to improved nutrition situation;
- NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** by the Regional Nutrition Committee of the National Capital Region in a meeting duly assembled, to adopt the Guidelines on the Shepherding of LNCs for implementation in the region, as per attached.
