**RESOLUTION APPROVING AND ADOPTING THE
REGIONAL NUTRITION COMMITTEE STRATEGIC PLAN (RNCSP) 2012-2016**

- WHEREAS,** the Medium-Term Philippine Plan of Action for Nutrition (MTPPAN) is the government's blueprint for action to address the country's nutrition problems as incorporated in the Philippine Development Plan (PDP) and is anchored on the Millennium Development Goals (MDGs), particularly those addressing poverty, hunger and malnutrition;
- WHEREAS,** the PPAN 2011-2016 aims to contribute to the (1) improvement of the quality of the country's human resource base, and 2) reduction in child and maternal mortality;
- WHEREAS,** the PPAN 2011-2016 has specific and quantitative targets to reduce various forms of malnutrition and identifies priorities for action to achieve set targets;
- WHEREAS,** there is a need to translate these strategies and priorities of action at the sub-national levels;
- WHEREAS,** the Regional Nutrition Committee (RNC) of the National Capital Region has formulated its Regional Nutrition Committee Strategic Plan (RNCSP) for 2012-2016 which identifies critical activities that the RNC as a collective body will implement to contribute to the achievement of the PPAN targets and desired nutrition outcomes, particularly in the region;
- WHEREAS,** the RNCSP 2012-2016 recognizes that the cooperation of the national line agencies, local government units (LGUs), the civil society organizations (CSOs) and the private sector is primordial in the success of the Plan, thus, the cooperation and support of various nutrition stakeholders in the implementation of the Plan shall be vigorously sought through various activities;

RESOLVED FURTHER, to request the Regional Development Council (RDC) to adopt the Regional Nutrition Committee Strategic Plan for 2012-2016;


