REGIONAL NUTRITION COMMITTEE (RNC) RESOLUTION NO. 2, S. 2015

RESOLUTION ADOPTING THE GUIDELINES ON THE SHEPHERDING OF LOCAL NUTRITION COMMITTEES FOR IMPLEMENTATION IN REGION I

WHEREAS, the Regional Nutrition Committee (RNC), an inter-sectoral body composed of Regional Directors or regional heads of national government agencies and other bureaus or agencies and representatives from the private sector, is responsible for coordinating and monitoring the implementation of agency nutrition programs in support of the Philippine Plan of Action for Nutrition (PPAN) in the region;

WHEREAS, part of the RNC's mandate is to issue policies, guidelines and or recommendations that will support the nutrition program in the region;

WHEREAS, the RNC sees the need for closer monitoring and mentoring of local nutrition committees based on the results of the annual Monitoring and Evaluation of Local Level Plan Implementation (MELLPI) and Program Implementation Review (PIR) to improve their nutrition program management;

WHEREAS, the Regional Nutrition Planning and Evaluation Team (RNPET), being the technical arm of the RNC, is represented by the middle managers/representatives of member agencies of the RNC

WHEREAS, the shepherding of Local Nutrition Committees (LNCs) is a strategy established by NNC-NCR will be adopted by the RNC to allow frequent monitoring visits to local government units by the members of the RNPET for in-depth interaction with and mentoring of LNC members to assist them in improving their nutrition program management resulting to improved nutrition situation;

NOW, THEREFORE, IN CONSIDERATION OF THE ABOVE PREMISES, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Regional Nutrition Committee of Region I in a meeting duly assembled, to adopt the Guidelines on the Shepherding of LNCs for implementation in the region, as per attached.

RESOLVED FURTHER, that the National Nutrition Council- Regional Office I being the Secretariat of the Regional Nutrition Committee is hereby tasked to take the lead and coordinate the implementation of the shepherding of local nutrition committees;

RESOLVED FURTHER, that this resolution shall be reviewed after three years upon approval;

RESOLVED LASTLY, that the NNC-Regional Office to furnish the NNC Central Office, all regional members of the RNC and all local government units in the region a copy of this resolution.
