## **REGIONAL NUTRITION COMMITTEE (RNC) RESOLUTION NO. 3, S. 2015**

## AFFIRMING THE ORGANIZATION OF THE REGIONAL NUTRITION CLUSTER IN REGION 1

**WHEREAS**, the NNC Governing Board through Resolution No. 1, s. 2009 adopted the DOH National Policy on Nutrition Management in Emergencies and Disasters stipulating the guidelines in the delivery of nutrition services during emergencies and disasters;

WHEREAS, said resolution calls for the organization of nutrition clusters to prevent deterioration of the nutrition situation due to emergencies and disasters;

WHEREAS, DOH Department Personnel Order No. 2007 – 2492 mandates the creation of the cluster system under the DOH-Health Emergency Management Staff and identified NNC as the Chair of the Nutrition Cluster;

WHEREAS, the Regional Development Council Executive Committee - Region 1 (RDC EXCom-1) passed the RDC ExCom Resolution No. 60, s. 2014, dated December 17, 2014, "Enjoining Local Government Units to Organize their Nutrition Cluster";

WHEREAS, at the regional level, the Regional Nutrition Council organized the Regional Nutrition Cluster during its special meeting on May 8, 2014;

NOW, THEREFORE, and in consideration of the above premises, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to approve the organization of the Regional Nutrition Cluster in Region 1;
