RDC – EXECUTIVE COMMITTEE Resolution No. 59, s. 2013

ENJOINING ALL LOCAL GOVERNMENT UNITS OF REGION 1 TO PROCURE/ FABRICATE HEIGHTBOARDS FOR USE IN THE MEASUREMENT AND ASSESSMENT OF THE NUTRITIONAL STATUS OF CHILDREN

WHEREAS, growth monitoring is a strategy in promoting health and quality of life through measurement and assessment of physical growth and development of individuals and groups in a community;

WHEREAS, the reference growth standards are values for weight and height at different ages used as reference point for the assessment of the nutritional status of individuals;

WHEREAS, the country adopted the World Health Organization-Child Growth Standards (WHO-CGS) in determining the weights and heights of 0-71 months old children as per DOH Administrative Order No. 88, s. 2012;

WHEREAS, triggered by the adoption of WHO-CGS, the annual weighing of all preschool children or Operation Timbang (OPT) has been expanded to include the measurement of height for children 2 years old and length for children less than 2 years old, or what is now called OPT Plus;

WHEREAS, the growth and measurement of children 0-5 years (0-71 months) shall be assessed by measuring their weights and heights/lengths regularly;

- a) For children 0 to less than 2 years (0-23 months) old, their weights and lengths shall be measured once a month
- b) For children 2-5 years (24-71 months) old, their weights and heights shall be measured twice a year
- c) The weight and height of a child shall also be measured every time they come in contact with health care system, e.g. when the child is sick and brought to the health center for consultation
- d) The weights of children 0-71 months old taken during Operation Timbang (OPT) shall be done once a year (January to March) and will cover at least 16.2% of the total population.

WHEREAS, the World Health Organization has recommended the use of wooden heightboards and has drawn up technical specifications for the procurement / fabrication or calibrated and verified heightboards;

WHEREAS, as of January 29, 2013, the inventory made by the Regional Nutrition Committee (RNC) revealed that only 24.0% of the total barangays in the region have procured/fabricated heightboards;

WHEREFORE, upon the recommendation of the Regional Social Development Committee (RSDC) through RSDC Resolution No.8, s. 2013 dated June 21, 2013 and on motion duly seconded;

RESOLVED FINALLY, to request the Department of the Interior and Local Government (DILG) in cooperation with the National Nutrition Council to monitor LGUs' action on the said resolution;
