EXECUTIVE ORDER NO. 9, series 2014

AMENDMENTS TO EXECUTIVE ORDER RECONSTITUTING THE PROVINCIAL NUTRITION COMMITTEE

WHEREAS, R.A. 7160, otherwise known as the Local Government Code of 1991, mandates LGUs to provide basic social services like health and nutrition.

WHEREAS, the Provincial Nutrition Committee is responsible for the nutrition program to the constituents of the Province of Lanao del Norte, more particularly the indigents;

WHEREAS, the Provincial Nutrition Committee had already been organized and existing, however, because of the present conditions, it has been observed and noted that the Committee needs to be reconstituted and reorganized;

WHEREAs, we take cognizance of the Philippine Plan of Action for Nutrition which is:

- 1. Program on Infant and Young Child Feeding
- 2. Food Fortification Program
- 3. Micronutrient Supplementation program
- 4. Nutrition Education
- 5. Home, School, and Community Food Production program
- 6. Healthy Lifestyle Program
- 7. Hunger Mitigation Program
- 8. Water, Sanitation and Hygiene Program

WHEREAS, the National Council likewise issued the National Policy on Nutrition Management in Emergencies and disasters wherein the local nutrition committee shall function as the local nutrition cluster;

WHEREAS, in order to reconstitute and revitalize the Provincial Nutrition Committee, the following structure and organization leadership is hereby instituted, to wit:

Now, therefore, I, MOHAMAD KHALID Q. DIMAPORO, by virtue of the powers vested in me as the Chief Executive of the Province of Lanao del Norte, do hereby order the following:

Section 1. Reconstitution of the Province of Lanao del Norte Nutrition Committee. The Province of Lanao del Norte Nutrition Committee is hereby reconstituted.

Section 2. Composition. The Lanao del Norte Nutrition Committee shall be composed of the following:

Section 3. Secretariat. The Provincial Health Office -- Provincial Nutrition Action Officer (PNAO), shall serve as secretariat of the Lanao del Norte Provincial Nutrition Committee.

Section 4. Functions. The Provincial Nutrition Committee shall have the following functions:

- 1. Formulate the Provincial Nutrition Action Plan, Hunger Mitigation Plan, Policies and Programs.
- 2. Advocates for the adaption and financing of the plan;
- 3. Coordinates and monitors nutrition and nutrition-related activities of the member agencies and the other agencies;
- Mobilizes resources to ensure the plan is implemented;
- 5. Conducts periodic visits and meetings with the Barangay Nutrition Committee to assess progress of program implementation and recommends appropriate actions;
- 6. Provide technical assistance to the Barangay Nutrition Committee;
- 7. Evaluates the performance of Barangay Nutrition Plan using MELLPI Tool;" (Monitoring and Evaluation at Local Level Plan Implementation)
- 8. Evaluate the performance of Barangay Nutrition Scholars;
- 9. Holds regular quarterly meeting to assess plan implementation;
- 10. Introduces innovation in the management of nutrition program.

Section 5. Special Functions. The Lanao del Norte Provincial Nutrition Committee (LDNPNC) will be in-charge of nutrition management during emergencies and disasters.

The LDNPNC shall function as the local nutrition cluster. The cluster shall be considered as a sub-structure of the local disaster coordinating council.

The LDNPNC shall coordinate with other local clusters such as Water, Sanitation & Hygiene (WASH), Mental Health & Psychosocial Support, Social protection, Food and Non-Food clusters.

Section 6. Technical Working Group. There shall be a technical working group of Lanao del Norte Provincial Nutrition Committee that shall compose of, but not limited to, the following:

- 1. The Provincial Nutrition Action Officer
- 2. A representative from the Provincial Health Office
- 3. Representatives from the office of the Provincial Agriculturist
- 4. A representative from the Office of the Provincial Veterinarian
- 5. A representative from the Provincial Social Welfare and Development Office
- 6. A representative from the Provincial Planning and Development Office
- 7. A representative from the Provincial Budget Office
- 8. The Manager of the Public Employment Service Office
- 9. A representative from the Health and Nutrition Section of Dep.Ed. Division of Lanao del Norte
- 10. A representative from the Provincial DILG

Section 7. Functions of the Technical Working Group. The Technical Working Group shall have the following functions:

- 1. Prepares the 3-years Provincial Nutrition Action Plan
- 2. Conducts monitoring visits to the barangays
- 3. Conducts Provincial level MELLPI and Outstanding BNS evaluations

Section 8. MEETING/FUNDS

This Provincial Nutrition Council shall meet quarterly on every first Thursday of January, April, July and October at 9:00 to 5 o' clock in the afternoon. Special Meeting be called upon the chairperson as the need arises.

Fund support for the meetings and operations of the Council will be charge from the funds of the mandated Bodies and from the office of the Governor.
