## EXPANSION OF THE MEMBERSHIP OF THE REGIONAL NUTRITION COMMITTEE TO INCLUDE THE NORTHERN MINDANAO NUTRITION ACTION OFFICERS ASSOCIATION OF THE PHILIPPINES (NAOPA, INC.), DISTRICT/CITY NUTRITION PROGRAM COORDINATORS ASSOCIATION OF THE PHILIPPINES (DCNPCAP) AND NATIONAL BARANGAY NUTRITION SCHOLARS (BNS) FEDERATION, INC.

- WHEREAS, Nutrition Action Officers (NAOs), District/City Nutrition Program Coordinators (DCNPCs), and Barangay Nutrition Scholars are frontline nutrition workers at the local level acting as partners in promoting and implementing Presidential Decree No. 491 (Nutrition Act of the Philippines), Presidential Decree No. 1569 (Strengthening the Barangay Nutrition Program by providing for a Nutrition Scholar in Every Barangay) and the Philippine Plan of Action for Nutrition;
- WHEREAS, these frontline nutrition workers have joined hands in addressing the malnutrition problem of the country with the entire effort being coordinated by National Nutrition Council (NNC) and were organized into association as early as 2010;
- WHEREAS, the NAOPA, Inc., D/CNPCAP and National BNS Federation, Inc. has since then been recognized by the NNC as legitimate associations having been registered with the Securities and Exchange Commission;
- WHEREAS, the NNC has continually supported the quarterly meeting and national convention of these associations;
- WHEREAS, the NNC recognizes the need to provide the enabling environment for their representation in planning and decision-making processes using the breadth and depth of their knowledge and experience;
- WHEREAS, the Regional Nutrition Committee (RNC), the function of which among others is to formulate policies and directions for nutrition program implementation, will serve as the platform for the representation of these associations;
- WHEREAS, there is a need to include the NAOPA, Inc., D/CNPCAP and National BNS Federation, Inc., through its elected presidents, as members of the RNC;

- **BE IT RESOLVED, THEREFORE, AS IT IS HEREBY RESOLVED,** on motion duly seconded that the membership of the RNC is hereby expanded to include the Northern Mindanao NAOPA, Inc., D/CNPCAP and National BNS Federation, Inc;
- **RESOLVED FINALLY**, that copies of this resolution be furnished to NNC, members of the RNC, the NAOPA Inc., D/CNPCAP, National BNS Federation Inc., provincial/city LGUs, and all concerned entities for support as well as to ensure their active participation.
