## RDC XII Resolution No. 12, Series of 2018

## SUPPORTING THE PHILIPPINE PLAN OF ACTION FOR NUTRITION, 2017-2022

- WHEREAS, the Philippine Plan of Action for Nutrition (PPAN), 2017-2022 is the country's framework for nutrition action which aims to improve the nutrition situation of the country towards improving human capital and reducing vulnerabilities brought by malnutrition;
- **WHEREAS**, it contains nutrition specific and sensitive programs that will address the immediate and underlying causes of malnutrition, and the enabling programs that will help propel the implementation of these nutrition programs;
- WHEREAS, nutrition sensitive programs are sectoral programs that were tweaked to contribute to the nutritional outcomes like livelihood and employment opportunities, among others;
- WHEREAS, the PPAN, 2017-2022 also gives importance to the first 1,000 days of life because good nutrition starts at the mother's womb; hence, feeding program for pregnant women is among the priority activities;
- WHEREAS, during the 1<sup>st</sup> quarter meeting of the Regional Social Development Committee (RSDC) XII on March 7, 2018 in Koronadal City, the Committee finds the plan to be consistent and supportive of the AmBisyon Natin 2040, the Philippine Development Plan, 2017-2022, and the socio-economic agenda of the current administration;
- NOW, THEREFORE, on motion of Hon. Richlie Lyndon L. Magtulis, Private Sector Representative for Sarangani Province, and duly seconded by Hon. Alfredo Bronx P. Hebrona, Jr., Private Sector Representative for Infrastructure Sector, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that RDC XII support the Philippine Plan of Action for Nutrition, 2017-2022.
- **RESOLVED FURTHER**, that a copy of this resolution be furnished each the Central and Regional Office XII of the National Nutrition Council, for information.
