**ENDORISING THE FY 2015 BUDGET PROPOSAL FOR THE PRIORITY PROGRAMS,  
PROJECTS AND ACTIVITIES OF THE NATIONAL NUTRITION COUNCIL (NNC)  
REGIONAL OFFICE XII**

**WHEREAS,** in compliance with Executive Order No. 325, Series of 1996, National Budget Memorandum No. 119 dated 27 December 2013 and National Budget Memorandum No. 120 dated 06 January 2014, the Regional Development Council (RDC) XII Executive Committee (ExCom) conducted the Consultation and Review of FY 2015 Budget Proposals of Regional Line Agencies (RLAs), State Universities and Colleges (SUCs), and other National Government Instrumentalities in Region XII on February 18-21, 2014;


