Regional Nutrition Committee Resolution No. 001, Series 2013:

**ADOPTION OF THE MIMAROPA REGIONAL NUTRITION COMMITTEE
STRATEGIC PLAN 2012 – 2016**

- WHEREAS,** the Regional Nutrition Committee of MIMAROPA plays a critical role for nutrition action as it serves as a link between the national government and local government units and communities to allow for policy formulation that is more rooted to realities at the ground and for implementation of nutrition programs and projects that are inspired not only by local realities but also by national directions;
- WHEREAS,** the Regional Nutrition Committee acknowledges the nutrition challenges in the MIMAROPA Region and the role that nutrition plays in developing not only the region but the whole nation as well;
- WHEREAS,** members of the Regional Nutrition Committee of MIMAROPA, representatives of local government units, and nutrition workers convened to assess the current nutrition situation of the region and, thus, to formulate the Regional Nutrition Committee's Strategic Plan for 2012 to 2016;
- WHEREAS,** nutrition reflects the underlying social and economic conditions at the household, community, and national levels that are supported by political, economic, and ideological structures within a nation;
- WHEREAS,** MIMAROPAns are envisioned to make conscious eating choices, linking it to good health and nutrition in order to bring greater fulfillment to life and individual well-being through the "Eat-to-Nourish" principle, with four major strategies namely policy development and plan formulation, monitoring and evaluation, advocacy, and enabling mechanisms as means to address nutritional problems of MIMAROPAn families;




NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to adopt the MIMAROPA Regional Nutrition Committee Strategic Plan for 2012 to 2016 as a framework of action to uplift the nutritional situation in the MIMAROPA Region.

RESOLVED FURTHER, to enjoin all other stakeholders to support the framework of action for the MIMAROPA Region.


