Excerpts From The Minutes Of The 1st Quarter Meeting of the Regional Nutrition Committee of MIMAROPA Held On March 18, 2013 at the Fernando Generics Hall, Center for Health Development IV-A Building, Quirino Memorial Medical Center Compound, Project 4, Quezon City

Regional Nutrition Committee Resolution No. 002, Series 2013:

APPROVING THE CONDUCT OF THE 2013 MONITORING AND EVALUATION OF LOCAL LEVEL PLAN IMPLEMENTATION (MELLPI) AND EVALUATION OF NOMINEES TO THE REGIONAL OUTSTANDING BARANGAY NUTRITION SCHOLAR

WHEREAS, the National Nutrition Council which is composed of different national government agencies collectively designated as the NNC Governing Board, and a Secretariat is mandated to coordinate the planning, monitoring and evaluation of different nutrition programs;

WHEREAS, in 1979, the National Nutrition Council has established and has institutionalized the Monitoring and Evaluation of Local Level Plan Implementation (MELLPI) system for the following purpose: a) to assess the efficiency of local level implementation of the Philippine Plan of Action (PPAN) in terms of outreach activities conducted, funds expended as well as the management and support given by local executives and other implementing agencies; b) to measure change in nutritional status of target population; c) to determine the extent to which nutrition is integrated in local development plans and programs; d) to document best practices; and e) to advocate for continuing support for local nutrition programs;

WHEREAS, NNC is also mandated to evaluate the Barangay Nutrition Scholars (BNSs) as community-based health and nutrition volunteers to assist in the planning and coordination of the Barangay Nutrition Committee, promote, advocate, and implement nutrition and nutrition-related programs, monitor and evaluate the nutrition situation and program, assist in resource mobilization/ generation for nutrition and nutrition-related programs, and document and record keep nutrition and nutrition related data and information their area;

WHEREAS, MELLPI and BNS evaluation are regular activities conducted annually to comprehensively determine local level nutrition program implementation and the advocacies and efforts being promoted in the community;



WHEREAS, the MIMAROPA Regional Nutrition Committee (RNC) designated Regional Technical Working Group cum Regional Evaluation Team members to conduct the annual MELLPI and BNS evaluation in the region for CY 2013 with the Department of Interior and Local Government Regional Office IV-B unanimously voted as Chair of the Regional Evaluation Team and the Department of Agriculture as Vice-Chair, respectively;


WHEREAS, the schedule of the 2013 MELLPI and BNS evaluation in the region will commence from April 2013 to July 2013, covering the five provinces and two cities of the Region;

WHEREAS, the MELLPI and BNS Evaluation is an opportunity to evaluate intensively the implementation of nutrition at the local level while focusing on the impact of such on the nutrition and health concerns of the populace in the area.


