STRENGTHENING THE ORGANIZATION OF THE REGIONAL BANTAY ASIN TASK FORCE (RBATF) IN REGION VI

Resolution No. 04 Series of 2016

WHEREAS, RA 8172 otherwise known as "An Act Promoting Salt Iodization Nationwide and for Related Purposes", or commonly called "ASIN Law" is a major step to end Iodine Deficiency Disorders (IDD) through the cost-effective preventive measure of salt iodization;

WHEREAS, effective implementation of the law requires a strong mechanism for monitoring to ensure that only adequately-iodized salt is available for human and animal consumption;

WHEREAS, such mechanism can involve the organization of a group of monitors of adequatelyiodized salt in the region;

NOW THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED, in consideration of the foregoing; that the Regional Bantay Asin Task Force of Region VI be organized with Department of Health (DOH), Region VI as lead and chair, composed of the following organizations;

And with the following functions:

- Manage and coordinate the NSIP in the region by formulating an annual NSIP operational plan, provide technical assistance to local BATF and coordinating with stakeholders like salt producers and traders;
- 2. Lead in advocacy in the region for full and effective implementation of the ASIN Law including, ensuring sustainable support to the program;
- Monitoring and evaluating program implementation through meetings for update on program implementation problems and issues, visits to warehouses of salt producers, and monitoring salt in ports; and
- 4. Recommending to the Regional Nutrition Committee, National Salt Iodization Programrelated regional policies;

RESOLVED FURTHER, for the National Nutrition Council in Region VI to provide secretariat and technical assistance to the Bantay Asin Task Force;

RESOLVED FURTHER, for this resolution to be disseminated to partners and stakeholders involved and to be considered for review in 2018.
