## RNC Resolution No. 012-01-A (s 2012)

## "REQUESTING THE CENTRAL VISAYAS REGIONAL DEVELOPMENT COUNCIL TO ENJOIN NUTRITION STAKEHOLDERS, ESPECIALLY THE LOCAL GOVERNMENT UNITS, TO ADOPT THE REGIONAL NUTRITION STRATEGIC PLAN 2012-2016"

WHEREAS, the Medium-Term Philippine Plan of Action for Nutrition (MTPPAN) 2011-2016 provides the national framework on nutrition which is anchored on the Philippine Development Plan (PDP) and the Millennium Development Goals particularly, goals to address extreme poverty, hunger and malnutrition;

WHEREAS, the Central Visayas Regional Development Council (RDC 7), during its meeting on 24 June 2011, passed RDC Resolution No. 21 s. 2011, "Supporting the implementation of the Medium Term Philippine Plan of Action for Nutrition (MTPPAN) by enjoining LGUs to implement programs, activities, projects that support the MTPPAN Strategies";

WHEREAS, there is a need to translate the MTPPAN framework into specific strategies and activities at the subnational levels to serve as reference and quide for nutrition stakeholders, especially the LGUs, in the implementation of the MTPPAN;

WHEREAS, the Regional Nutrition Committee has formulated the Central Visayas Regional Nutrition Strategic Plan for the period 2011-2016 which provides for specific strategies and actions consistent with the MTPPAN framework and considers past and emerging nutrition situation of the region;

WHEREAS, the ultimate success of the Regional Nutrition Strategic Plan is founded on the basic premise of complementation and convergence of efforts and resources among the Regional Nutrition Committee member agencies, local government units, non-government organizations, and other stakeholders on the plan's implementation;

WHEREAS, the RNC believes that the proposed RDC action of enjoining the nutrition stakeholders to adopt the Central Visayas Regional Nutrition Strategic Plan, 2012-2016, would further reinforce the RDC's expression of support to the MTPPAN;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to request the Central Visayas Regional Development Council to enjoin nutrition stakeholders, especially the LGUs, to adopt the Central Visavas Regional Nutrition Strategic Plan for the period 2012-2016;

RESOLVED FURTHER, to request the Department of the Interior and Local Government 7 to direct/encourage the Central Visayas LGUs, through their respective Local Nutrition Committees (LNCs), to formulate local nutrition action plans consistent with the Central Visayas Regional Nutrition Strategic Plan.
