FLORES, CESO II, herein referred to as "NNC"; and

The **MANILA BROADCASTING COMPANY**, with office address at Star City Complex, Vicente Sotto Street, Roxas Blvd., Pasay City represented herein by its Drama Manager, **SALVADOR M. ROYALES**, herein referred to as **"MBC"**.

WITNESSETH

WHEREAS, the NNC shall produce and air Season 12 of "Katumbas ay Biyaya", a 30minute drama series on nutrition as provided in the Terms of Reference hereto attached as Annex 1;

WHEREAS, a market study, hereto attached as Annex 2, was conducted to determine the most appropriate contractor for the production and airing of "Katumbas ay Biyaya Season 12" which showed the Manila Broadcasting Company which operates the DZRH radio station as the best contractor for the project;

WHEREAS, the Bids and Awards Committee (BAC) of the NNC, through BAC Resolution No. <u>08-2017</u> hereto attached as **Annex 3**, recommended the alternative method of procurement, particularly Negotiated Procurement for the production and airing of "Katumbas ay Biyaya Season 12";

WHEREAS, Manila Broadcasting Company has signified its interest to undertake the project;

NOW, THEREFORE, for and in consideration of the foregoing premises hereinafter stipulated, the parties have agreed as follows:

- 1. Obligations of the Manila Broadcasting Company:
 - a. develop, produce and air 52 episodes of drama at 30 minutes per episode to be aired during Saturdays between 10:00 a.m. and 11:00 a.m.;
 - b. submit to NNC, for approval, the scripts of the drama prior to production;
 - c. conduct an on-air contest among listeners for each episode and provide Php100 cellphone load each to the first 5 phone-in callers or texters with the correct answer to the question for the week;
 - d. conduct a contest among listeners for sending their true life stories on the positive influence of *"Katumbas ay Biyaya"* and feature these in the program, and provide the 10 winning entries with cash prizes of at least Php10,000 each;
 - e. air nutrition plugs of the NNC on rotation basis at four plugs per episode and three nutrition plugs on rotation basis from Sunday to Friday for the duration of the airing of the 52 episodes;
 - f. inform the NNC in writing of any pre-emption in airing of episodes or changes in schedules and provide corresponding airtime for missed episodes and spots for nutrition plugs;
 - g. prepare and submit entries to award-giving bodies for broadcast industries including *Kapisanan ng mga Brodkaster ng Pilipinas* Golden Dove Awards and Catholic Mass Media Awards;
 - develop, maintain and update social media accounts including Facebook and Twitter of the program including but not limited to linking audio streaming of the program, content marketer everyday monitoring of inquiries and/or comments of the listeners and followers of the program in Facebook page; post text contest winners weekly and post episodic plug weekly, lay-out and post announcements about the program and load contest for the first 100 Facebook likes and shares and first 50 Twitter favorites and retweets; and

- b. review and approve all drama scripts prior to production and prior to airing;
- c. provide nutrition plugs for airing;
- d. prepare the talking points for the technical discussion of each episode and questions for the text contest;
- e. provide the necessary technical assistance and reference materials for the development of the drama component for each episode;
- f. provide nutritionist-dietitians as resource speakers for the technical discussion in the various episodes;
- g. monitor the weekly airing of the drama episodes;
- h. monitor the Facebook and Twitter accounts of the program;
- i. review and identify with the contractor the winning letter senders for airing of their true life stories on *Katumbas ay Biyaya*;

5. Penalty Clause

This contract shall be implemented as agreed upon in accordance with the terms and conditions stipulated herein. Failure on the part of MBC to comply with the provisions of this contract shall be cause for the imposition of appropriate penalties or the contract's termination.

A penalty of one tenth (1/10) of one percent (1%) of the total project cost will be deducted from the final payment for every day of delay in the submission of required outputs for causes attributable to MBC after the end of the project. However, in the event where work is delayed due to delays in the approval of the materials by NNC or other reasons beyond the control of MBC, both parties shall mutually concur and agree in writing on a revised schedule or work plan.

6. Duration and Effectivity

This contract shall take effect on the date of the issuance of Notice to Proceed by the NNC to MBC and shall remain in force until May 2018, unless otherwise modified or amended by mutual consent of parties concerned. Provisions of this contract may be modified, altered, supplemented or amended subject to the mutual written agreement of both parties that can be in a form of letters of conforme.

7. Venue

In case of disputes arising from the interpretation or implementation of this Contract, the courts of Taguig City shall have exclusive jurisdiction to the exclusion of all other courts. However, all claims and disputes relating to or arising out of this contract shall as much as possible, be settled amicably by the parties before resorting to any judicial action.

8. Miscellaneous provisions

In the event that situations arise that render this Contract disadvantageous to the NNC, the parties hereto agree to immediately re-negotiate the terms of the Contract.

This Contract may be executed in any number of counterparts, such as through letters of conforme, and shall all together be considered as part of the Contract.
